Joy Hughes is improving. Here are excerpts from a report by **Paula:** "She will be discharged from the hospital on Monday. Since she is still weak, she will go back for rehab at HealthSouth Vision Park in The Woodlands. Her toes will recover, but she will lose part of her big toe. This is a blessing, because she could have lost her foot or even her leg." While Paula was able to attend a Passover service with friends in Houston last Sunday, Joy is anticipating partaking of the second Passover.

Here are updates for **Boyd** and **Annette Payne.** Boyd reports that a doctor told him that his liver might be abnormal, so there is another doctor appointment in Longview on Tuesday. Annette reports that her ankle swells slightly during the day and the swelling goes down at night. Since they haven't been driving, they kept a meaningful Passover service at home last Sunday (after **Dave Havir** took them unleavened bread, a program and a music CD). However, they hope that a son can bring them to the church service today.

Ron and **Gracie Feaker** report that they have had a good week. They have been able to attend the Passover service in the building and the church service on Tuesday. Gracie said that the two of them cooperated to cook a roast on Thursday.
