There is hope yet for America. Larry Elder is a host of a successful talk show on KABC Radio in Los Angeles and a nationally syndicated columnist who wins the imprimatur of a major book publisher to carry a big message. As a black libertarian, he is also a breath of fresh air in his courage and plain speaking.

Elder is even something of a firebrand. Here he daringly takes on the Fortress America of Political Correctness on and off the campus, in and out of the mainline media, from and to the church pulpit. And so he assails ten supposedly unassailable yet monumentally politically correct paradigms.

Here are his topics:

1. Blacks Are More Racist than Whites
2. White Condescension Is as Bad as Black Racism
3. The Media Bias: It’s Real, It’s Widespread, It’s Destructive
4. The Glass Ceiling—Full of Holes
5. America’s Greatest Problem: Not Crime, Racism, or Bad Schools—It’s Illegitimacy
6. There Is No Health-Care “Crisis”
7. America’s Welfare State: The Tyranny of the Statist Quo
8. Republicans Versus Democrats: Maybe a Dime’s Worth of Difference
9. The War Against Drugs Is Vietnam II: We’re Losing This One, Too
10. Gun Control Advocates: Good Guys with Blood on Their Hands.



Those are indeed things that can't be said in most circles, but Elder argues his points with great assurance. He says out loud what Americans only whisper at the kitchen table, on the shop floor, or at the water cooler. Something has gone wrong.

We have become, he maintains, a nation of whimpering people who won't take responsibility for our own actions, but furiously rage that the problem is always someone or something else.

Here's a choice cut of Elder's rhetoric: "We've become a nation of 'victicrats' . . . The glass ceiling? Nonsense. Hate crimes? All crimes are hateful. O.J. Simpson? He did it, and his defense team shamelessly used the black victicrat mentality to escape conviction."

Books by talk-show hosts tend to be unscholarly, but not this one. Elder has done his homework. *Ten Things You Can't Say in America* is heavily documented, with many graphs and tables.

Larry Elder's book is a triumph of common sense, with enough nerve to shake up the dreary statist quo. It is a passionate plea for limited government and personal responsibility. Let us hope to hear more from him.

When did the civil rights movement go off the rails?

The answer is when proponents went from justly demanding equal rights to unjustly demanding equal *results*. As to exactly when this occurred, that's more difficult to answer. But consider statements, made five years apart, from the Kennedy brothers, John F. and Robert F.

Neither brother was asked about nor used the word "reparations." But during an August 1963 press conference, a reporter asked President John Kennedy about "special dispensation" for Blacks: "Mr. President, some Negro leaders are saying that, like the Jews persecuted by the Nazis, the Negro is entitled to some kind of special dispensation for the pain of second-class citizenship over these many decades and generations. What is your view of that in general, and what is your view in particular on the specific point that they are recommending of job quotas by race?"

JFK replied: "I don't think that is the generally held view, at least as I understand it, of the Negro community, that there is some compensation due for the lost years, particularly in the field of education.

"What I think they would like is to see their children well educated so that they could hold jobs and have their children accepted and have themselves accepted as equal members of the community. So I don't think we can undo the past. In fact, the past is going to be with us for a good many years in uneducated men and women who lost their chance for a decent education.

We have to do the best we can now. That is what we are trying to do. I don't think quotas are a good idea. I think it is a mistake to begin to assign quotas on the basis of religion or race or color, or nationality.

"I think we get into a good deal of trouble. Our whole view of ourselves is a sort of one society. That has not been true. At least that is where we are trying to go. I think that we ought not to begin the quota system. On the other hand, I do think that we ought to make an effort to give a fair chance to everyone who is qualified, not through a quota, but just look over our employment rolls, look over our areas where we are hiring people, and at least make sure we are giving everyone a fair chance, but not hard and fast quotas. *We are too mixed, this society of ours, to begin to divide ourselves on the basis of race or color.*" (Emphasis added.)

That same year, National Urban League Executive Director Whitney Young proposed a 10-year "domestic Marshall Plan" for Blacks to make up for past discrimination. His board of directors opposed it. The president of the Pittsburgh Urban League chapter said the public would ask: "What in blazes are these guys up to? They tell us for years that we must buy (nondiscrimination) and then they say, 'It isn't what we want.'"

Five years later, Sen. Robert Kennedy announced his candidacy for president. He said: "I run to seek new policies—policies to end the bloodshed in Vietnam and in our cities, policies to close the gaps that now exist between Black and white."

"Policies to close the gaps that now exist between Black and white"? In 1940, 87% of Blacks lived below the poverty level. By 1960, that number dropped to 47%, a 40-point drop in 20 years, the greatest 20 years of economic growth for Blacks in American history. *Brown v. Board of Education*, which struck down "separate but equal," was not decided until 1954. This sharp decline in Black poverty preceded the Civil Rights Act of 1964.

John Kennedy was right. We cannot undo the past. But by teaching Blacks to see themselves as victims deserving of "reparations" from today's white "oppressors," we can certainly make the present and future worse.

Democrats are pushing another federal takeover of elections with the so-called John Lewis Voting Right Advancement Act. This one is a power grab forcing states to get permission from the Democrat-controlled federal government before implementing election integrity measures like voter ID and other constitutional safeguards.

While the fate of the Corrupt Politicians Act (H.R. 1 and S. 1) remains uncertain, Democrats are positioning for Plan B to blow up the Constitution's design of states having the primary role in elections, with Congress and the federal government having only a narrow role for issues like voting rights violations due to race.



There are two big guns in the Voting Rights Act of 1965, which was passed to enforce the Fifteenth Amendment. One is Section 2, which is a permanent nationwide ban on any state or local election laws that discriminate based on race or color.

The other was Section 5. That part said that certain parts of the country must get permission from the U.S. Department of Justice (DOJ) or the federal district court in Washington, DC before changing any of their election laws or redrawing legislative district lines after each decade's national census.

The Supreme Court upheld preclearance in 1966, emphasizing that Congress had identified some states with the most egregious forms of systematic black voter suppression. Make no mistake here: We're talking about fire hoses, attack dogs, beatings, and other shocking images. The justices explained that only such extreme circumstances could justify something like preclearance.

That America no longer exists. We now live in a country where black men and women are elected to statewide offices, and where a black man was elected president and a black woman vice president.

In fact, black turnout percentages in 2012 exceeded white turnout.

It's no surprise then that in 2013 the Supreme Court struck down part of preclearance. Specifically, the justices struck down the part of the law that determined which states must get preclearance, noting that the data in the law was from 1972—more than four decades old.

The Court said Congress could try preclearance again only if it had data to show where in America the same kind of abhorrent suppression is going on today as went up in parts of the Deep South in the 1960s.

Instead of doing that—because no such terrible things are happening in America today—the Democrats wrote H.R. 4 in 2019, extending preclearance nationwide to any state that tries to implement election integrity laws.

That's right: Joe Biden, Kamala Harris, Nancy Pelosi, and Chuck Schumer are saying that every state in America is as bad as the bullhorns, firehoses, and attack dogs of years past. They're calling America a systemically racist nation.

And make no mistake: The Biden-Harris Administration would object to any state attempting to implement those commonsense safeguards. Even though the state can take the matter to court, it really puts a thumb on the scales once DOJ says that a state is violating voting rights.

What's more, because you have to file in the liberal federal court in D.C. then go up to the liberal D.C. Circuit court on appeal, you'd probably have to get all the way to the Supreme Court to win—which can take years. Every step of the way, media pundits and activists are calling you racist for even trying.

Senate Democrats named S. 4263—which is their version of H.R. 4—the John Lewis Voting Rights Advancement Act, naming it after the recently deceased congressman who was one of the civil rights movement leaders in the 1960s.

So far this year, Biden, Harris, and their Democrats have been pushing H.R. 1, the complete federal takeover of elections. But not a single Republican has

supported it in the House or Senate, and a key moderate, Sen. Joe Manchin (D-WV), has said so far that he is unwilling to blow up a century of Senate filibuster rules to ram through that bill.

Now Democrats are preparing to re-introduce the John Lewis bill for this current Congress. If they get it, it would give them much of what they were trying to do with H.R. 1.

One of the interesting dynamics in this shift is the outsized role that Manchin plays in it. Manchin issued a statement with moderate GOP Sen. Lisa Murkowski (R-AK) calling on Congress to pass this legislation, unlike H.R. 1/S. 1, which Murkowski opposes outright, and which Manchin expressed concern about that bill passing in its current form.

Contrast that with the deceptive John Lewis bill. Manchin and Murkowski are supporting it, though they also said that bill should pass through “regular order”—meaning the normal process with all the rules, including the filibuster rule.

So Democrats are trying to portray it as a voting rights bill instead of another attempted takeover, hoping to build public support to get a few more moderates to cave on this bill.

If a state enacts voter ID laws, then it automatically must get preclearance. This, despite the fact that polls show that a majority of black Americans support voter ID, as do a majority of Hispanics.

Same thing for redistricting. If it changes percentages of racial minorities—which happens all the time as people move around—that too puts a state under DOJ for preclearance.

Aside from these categories, this law says that if there are 10 instances of any voting problems anywhere in a state, that the whole state gets put under preclearance.

Let’s say that a single town or county in a state implemented some voting measure, and later statistics show that it impacts black voters differently than white voters. Even if no one intended to discriminate, that measure would still count as an incident to put the entire state under DOJ’s preclearance requirement.

It gets worse, though, because if a lawsuit settles that too counts toward preclearance. If a Democrat-controlled city in a Republican-friendly state adopted a measure and gets sued by the ACLU, then the city immediately settles the lawsuit, which could count as a violation. Those of us who have worked in politics for decades can imagine some Democrat mayor talking over dinner with his ACLU buddies, cooking up something to trigger a lawsuit, then settling out of it before anyone can dig to find that the whole thing was a scam to run up the score of “violations” to force the entire GOP stronghold under DOJ’s supervision.

Lawyers are saying that this bill would be ripe for a legal challenge if it ever passed. But conservatives have been burned often enough by the Supreme Court that no one should put all their eggs in that basket.

Instead, they should oppose the deceptive John Lewis Voting Rights Advancement Act for the far-left power grab that it is.

The legacy of Rev. Martin Luther King is being dishonored on a daily basis. Those who are trashing his noble record are not white supremacists; rather, they are professionals who claim to be fighting racism. These people work primarily in education, law, and the media. Regrettably, they are as heavily populated in the for-profit sector of the economy as they are in the non-profit sector.

It was in King’s 1963 “I Have a Dream” speech that he articulated his vision of America. While he made several references to problems facing blacks, ranging from discrimination in public accommodations to police brutality, he did so against the backdrop of respect for the American commitment to liberty, equality, and justice for all. Indeed, his “dream” was based on his conviction that these goals would eventually be reached.

Unlike today, where street anarchists and professional agitators are tearing down statues of American icons, King was celebrating these heroic figures. He opened his speech by referencing the Emancipation Proclamation, calling its author (Lincoln) “a great American.” He also credited the Founders, whom he called “the architects of our republic,” for writing “the magnificent words of the Constitution and the Declaration of Independence.”

King knew that the goals of these documents were a work in progress, but he was wise enough to know that the Founders gave us “this promissory note,” without which appeals to liberty, equality, and justice were impotent.

“America has given the Negro people a bad check,” he noted, but “we refuse to believe the bank of justice is bankrupt.” He never gave up hope, insisting that “Now is the time to make justice for all of God’s children.” That was a very Christian response.

Now contrast what King said with what our new ambassador to the United Nations recently said. Linda Thomas-Greenfield told reporters in New York City that “the original sin of slavery weaved white supremacy into our founding documents and principles.” Wrong. It was our inalienable rights that were weaved into our founding documents and principles.

King would have been appalled. He had nothing but praise and admiration for our founding documents and principles. His problem was with our failure to make good on what they embodied, namely the contents of the American creed.

Indeed, it was precisely the documents and principles that galvanized him to act—they were the “promissory note.” If anything, the existential reality of white supremacy at the time of the founding was the complete opposite of what our creed entailed, and it was this inconsistency that he used, to great effect, to leverage the civil rights movement.

I have a dream that my four little children will one day live in a nation where they will not be judged by the color of their skin but by the content of their character.

This classic statement by King is now seen as contemptible by those who promote critical race theory. The proponents expressly judge people by the color of their skin, treating the content of their character as meaningless. Their demonization of white people—asking them to repent for their alleged positions of privilege—is patently racist. To them, the individual does not count; only his collective ascribed status does. Ironically, that’s what the slave masters believed about blacks.

Martin Luther King would be very happy with legislation recently passed in Idaho. This law prohibits public schools from teaching that “any sex, race, ethnicity, religion, color, or national origin is inherently superior or inferior.” Who objects? Critical race theory advocates. This explains why the entire Oklahoma City School Board of Education slammed a law that is based on the Idaho legislation. One critic said the non-discrimination law was done to “protect white fragility.”

The governor of Oklahoma, Kevin Stitt, sounded very much like King when he said, “I firmly believe that not one cent of taxpayer money should be used to define and divide Oklahomans by their race or sex.” He added that “We can, and should, teach this history without labeling a young child as an ‘oppressor’ or requiring he or she feel guilt or shame based on their race or sex.”

Rev. Martin Luther King sought to bring the races together. Today’s brand of “anti-racism and discrimination” activists seek to drive the races apart. In doing so they are at odds with the principles upon which our nation was founded. Indeed, they are fomenting racism, thus dishonoring King’s legacy.

The Cultural Research Center at Arizona Christian University recently released the results of three surveys on religion. It revealed that most Americans do not hold to a biblical worldview; rather, they embrace a mixture of competing interpretations, many of which are grounded in one version of secularism or another. There are other findings, of a more specific nature, that also merit our attention.

The decline of a Judeo-Christian culture extends back decades, but it took until recently to see the full fruits of this development on an entire generation. More than four-in-ten millennials (those born between 1985 and 2002), for example, say they either don’t believe, don’t know, or don’t care God exists. A 2020 Barna Group and Impact 360 Institute study found that three-quarters of teens and young adults agree that what is “morally right and wrong changes over time;” 31% strongly agree and 43% somewhat agree.

These two findings are strongly related. Indeed, the former explains the latter. If, as taught from K-graduate school, that God is a chimera, it follows that there is no such thing as objective truth. Of course, if that were true, then those who believe this would have no moral grounds to protest calls to enslave them. Think about it. Who are they to protest someone's else's truth?

Those of us who believe in natural law and natural rights are not stuck in this jam. We believe that God is the source of truth, and that his teachings are encoded in the Ten Commandments. In other words, there are some things that are inherently wrong, and do not vary over time. Lincoln understood this, as did Rev. Martin Luther King; their deeds were driven by, and based on, these eternal truths.

Not surprisingly, the Cultural Research Center researchers found that millennials are the most likely age group to define success as "happiness, personal freedom, or productivity without oppression." As such, they believe that it is perfectly fine to have an abortion if it is performed "to reduce personal, economic, or emotional discomfort." Their political leanings, the surveys found, are decidedly liberal.

These results are the logical fallout of what happens when God and truth are jettisoned. Having rejected any external basis for truth, the nucleus of one's moral compass reverts to oneself. That being the case, happiness and comfort become paramount, and anything that stands in the way of their fulfillment is verboten.

Given this strain of radical individualism, how can society be expected to care for those in need? Having rejected the Mother Teresa model—it is the job of every individual to tend to the needy—there are only two choices left: do nothing or have the state provide for them.

The answer, for millennials, is the latter. The surveys disclose that they are the most likely to champion liberal "fiscal and social policies." So while services for the needy will be provided, they will come from the state, leaving us completely unburdened, save for taxes. That way we can pursue happiness and comfort, the twin measures of our wellbeing.

Dostoevsky was right. "If there is no God, everything is permitted." Anyone who thinks such an idea has benign consequences knows nothing about history.

Neville Chamberlain tried to appease Hitler, and World War II resulted. By trying to appease the Ayatollahs in Iran, Joe Biden may have started us down a path to World War III. On the day Biden became president, Iranian-built missiles began to rain down on Israel, America's closest ally in the Middle East and the only democracy in that troubled region.

These missiles, aimed at Israeli civilians, were launched from Gaza by Hamas and Islamic Jihad. Iran's Islamic Revolutionary Guard Corps provides both terror

organizations with funding and arms. Their missile launches from Gaza between January and early May were a test of the Biden administration's mettle.

Accurately perceiving Chamberlain-like weakness in the Biden, the Iranians urged Hamas and Islamic Jihad to launch more than 600 missiles between May 10 and 11 against Israeli civilians in Sderot, Askelon, Jerusalem and Tel Aviv. By Jan. 16, the Palestinian terror organizations had launched more than 3,000 missiles and incendiary weapons against Israeli civilians.

Nearly 90% of these deadly warheads, aimed at towns and cities, are being intercepted by Israel's Iron Dome defense system, but dozens of Israeli civilians have been killed and wounded. Every volley of missiles from Gaza prompts Israeli airstrikes and artillery fire against terror targets—where Hamas uses Palestinian civilians as human shields.

In our previous column, we warned how Biden's weakness in foreign policy puts the United States and its allies in peril by emboldening Iran's IRGC and the terrorist groups they support. We cautioned Biden's offer to reopen talks with Tehran on JCPOA (the Iran nuclear deal) would be perceived by friends and allies as a lack of resolve.

These alerts have fallen on deaf ears. Continuous Iranian provoked rocket attacks on Israeli civilians should tell the Biden administration their goal of "sustainable calm" is a phony solution. It is, in fact, an open door to Iranian aggression against Israel that could well ignite a worldwide conflagration.

The Biden administration's public acknowledgment, "Israel has a right to defend itself," is certainly valid. But the privately issued demand to, "de-escalate now" from Blinken to Israeli Foreign Minister Gabi Ashkenazi, tells the truth about Biden's anti-Israel foreign policy.

Demanding unilateral de-escalation by Israel is tantamount to insisting Israel forego defending itself. This is an impossible choice for the Jewish nation. Weakness and appeasement invite further aggression by Iranian proxies in Syria, Lebanon, and Iraq.

The conflict between Israel and Hamas is not new. They have fought three wars since 2007 when Hamas took control of Gaza. Each successive conflict has escalated beyond the scope of previous conflicts, but the attacks since May 10 dwarf previous assaults. Fortunately, Prime Minister Netanyahu is made of sterner stuff than Biden. He has promised Hamas will pay dearly for its attacks on Israel, a promise he is already keeping. He has also quietly made it clear to the Biden administration their demands for Israeli de-escalation are unacceptable.

The Israeli Defense Forces are defending their country. The extent to which this conflict escalates is in the hands of Biden, not Netanyahu. If Biden wants to prevent a wider war against our democratic ally, he ought to make clear the United States condemns all attacks on Israel from any quarter, and withhold any further "economic aid" to Palestinian entities.

And just to make sure this message is received where it matters most, he should announce the U.S. is withdrawing from the so-called talks in Vienna



on a new Iran nuclear weapons deal, and reinstate all economic sanctions on the Ayatollahs in Tehran. Doing so will most assuredly ensure the current aggression will abate. Failure to do these things will allow Iranian aggression to escalate, and history teaches where that could lead.

The latest academic fraud being inflicted on school children by leftist ideologues is critical race theory. Biden tax plan would cull financial data on masses of law-abiding, tax-compliant Americans. In the name of catching tax dodgers, the Biden administration is seeking serious snooping rights to oversee all American bank accounts and payment apps. "Instead of promising a chicken in every pot, Biden's plan promises an auditor at every kitchen table," commented Sen. Chuck Grassley (R-Iowa).

Under President Joe Biden's proposal, 87,000 new IRS employees would be hired and everyone could expect more scrutiny of the flow of money to and from their financial accounts.

As it stands now, the government gets alerted to most income when the payer reports it to the IRS. If someone comes into money and the payer doesn't report it to the IRS, the person paid is supposed to report this income—no matter how small—but it's difficult for the IRS to know if they do not do so. Estimates suggest that "opaque" income sources have a misreporting rate of 55 percent.

Biden would change this, putting thousands of new IRS agents in charge of monitoring how much money goes into and out of individual bank accounts and payment service providers (like Paypal and Venmo) each year and investigating people whose cash flow doesn't match what they report as income.

It's how the administration proposes paying for the massive new spending measures in Biden's American Families Plan. The schemes "would raise \$700 billion in additional tax revenue over the next decade," according to the American Families Plan Tax Compliance Agenda.

The administration talks about this increased IRS scrutiny as if it would only affect extremely wealthy tax scofflaws. But the extremely wealthy know they get extra IRS scrutiny and already have all sorts of tricks for shielding income from taxes and from regulators' view.

Rather, it's the folks who sometimes get paid "under the table" for informal gig work—babysitting, house cleaning, a stray manual labor job here and there, sex work, fixing a few cars, peddling homemade baked goods, occasional music gigs, selling things on eBay or Etsy, and so on—who probably aren't likely to have elaborate schemes for hiding a little stray income from their checking accounts and payment apps.

Maybe the IRS wouldn't investigate those who only bring in a relatively small amount of untaxed money—but maybe they would. After all, those 87,000 new employees can't all be catching wily millionaires and billionaires.

The bottom line is that the IRS would have an unprecedented ability to at least target even the tiniest bits of unreported income.

"Account flows don't actually represent income and deductions, so the government wouldn't be able to match these reports with tax returns as it does with W-2s," notes *The Wall Street Journal*. "The report says the information would give the government enough of a window into transactions to target audits more effectively where there are large discrepancies and that tax evaders would change their behavior because they know what information the government has."

Biden's report pledges that "audit rates will not rise relative to recent years for those with less than \$400,000 in actual income." Yet even if this pledge is kept, the IRS would still have a vast new mandate to spy on all sorts of U.S. financial accounts.

The plan would ultimately pull in data on masses of law-abiding, tax-compliant Americans, as Tax Policy Center Senior Fellow Steve Rosenthal pointed out in the *Journal*:

Although administration officials talk about going after wealthy tax dodgers with their expanded staffing, the bank reporting proposal wouldn't do much to them, he said. That is because the highest-earning Americans are employing more sophisticated tax-dodging techniques than just declining to declare all their income.

The bank-reporting rules are designed to get a different group of people altogether—business owners who inflate their deductions and don't report all their income.

"This is a political call by the Biden administration: Let's not tell those guys, small-business guys, what we're doing," Mr. Rosenthal said.

The Biden administration calls this equal-opportunity spying *equity*.

"Third party information reporting is already provided on . . . wage, pension, and unemployment income," states the American Families Plan Tax Compliance Agenda. "The President's proposal would help make tax administration more equitable by subjecting financial flows . . . to third-party reporting as well."

“The President’s proposal leverages the information that financial institutions already know about the accounts that they house,” the report states. “Financial institutions would add information about total account outflows and inflows to existing reporting on bank accounts,” giving the IRS “an additional lens into previously unreported income streams.”

All banks, brokerages, and other financial institutions would be required to report “gross inflows and outflows on all business and personal accounts from financial institutions, including bank, loan, and investment accounts.” The regime “would also cover foreign financial institutions and crypto asset exchanges and custodians,” and “reports would also be required from payment services providers so that businesses cannot shift out of traditional financial institutions to other kinds of platforms and avoid making their income visible to the IRS,” it says.

The report states that there would be “exceptions for accounts below a low de minimis gross flow threshold,” but not what that threshold would be. A footnote to this part simply states that “the proposal preserves significant flexibility for the Secretary and the IRS to design the new reporting requirements in the way that will be most effective for tax compliance efforts.”
