The most famous words of Franklin Roosevelt, America's longest-serving president, were, "The only thing we have to fear is fear itself."

One wonders if any world leader would or could say that today. We live in the Age of Fear.

All of my life, I thought love and hate were the two most powerful human emotions.

But owing to recent events, I have changed my mind.

I now understand that for most people, *fear* is the strongest emotion.

In fact, I've come to realize that it is possible to get people to do anything if you instill enough fear in them. Specifically, irrational fear.

Fear of covid-19, for example, is rational. But media and governments induced irrational fears. That's why millions of healthy people stayed indoors for a year or more, why a vast number of people wore masks while walking or sitting alone outdoors, and why so many parents did not allow their young children to play with

other children for a year or more, even though the covid-19 mortality rate among children was considerably less than the flu's mortality rate among children.

All of this was caused by irrational fear. It turns out that fear is not only more powerful than love and hate; in most people it is more powerful than reason. And when it is, it is far more destructive—to the individual and to society—than rational fear.

What is rational fear? When a soldier fears going into battle, that is rational. Soldiers cannot allow fear to control their behavior, but their fear is not irrational. If a mugger points a gun at you, it is rational to feel fear. If you are diagnosed with cancer, it is rational to experience fear.

Rational fear is not necessarily a bad thing. It is irrational fear that does the most harm—to yourself, to others and to all of society.

The Salem witch trials of the 17th century exemplified irrational fear leading to evil: the killing of women who were believed to be witches.

You would think that the Enlightenment of the 18th century, with its focus on reason and science, would have led to a great lessening of irrational fear.

It hasn't.

To cite a number of examples, an unknowable (but not small) number of Americans—usually among the best educated—prohibited their parents from seeing their grandchildren, either because the grandparents or the grandchildren were not vaccinated. They did this despite the fact that the number of young people infected with covid-19 was close to zero and despite the fact that there were extremely few cases of children infecting adults. Sweden kept its schools open for all students under the age of 16 throughout the pandemic, and studies have since confirmed that the risk to Swedish teachers of infection by students was extremely low. Such is the power of irrational fear.

To take another contemporary example, many people have decided not to have children because they fear that a warming planet represents an "existential threat" to life. Now, it is rational to be concerned about climate change, but it is irrational not to have children because of it. And it gets even more irrational. Their parents often support this decision, despite their deep yearning to be grandparents.

Irrational fear is also a major source of hatred. People hate what they fear. It was Germans' irrational fear of Jews—people who made up under 1% of the German population—that led to the unique evil known as the Holocaust.

Given the awful power of fear, what can you do to be less fearful?

The first thing you must do is determine whether your fears are rational or irrational.

And that can only be accomplished by thoroughly studying the issue—whatever it happens to be: global warming, a pandemic, racism or any other divisive subject.

For example, black people are told to fear white police because white police are racist and want to do them harm. This is largely an irrational fear. It is well-documented that in any given recent year, the number of unarmed black

Americans killed by police is under 20—nearly all of whom posed serious threats to the lives of the policemen who killed them.

Another example: Credible scientists and other experts who acknowledge that global warming is taking place, but contend that it is not an existential threat to life, are dismissed as “anti-science” and their views suppressed. Read them, and many of your fears will be allayed. (You might even decide to have children.)

Most fears are stoked by governments and their allies in mass media and in Big Tech, who in turn suppress contrary opinions. Therefore, please understand that when you hear only one opinion, and that opinion is designed to make you afraid, there is a good chance that your fears are irrational.

Determining whether your fears are rational or irrational is one of the most important things you will ever do. The quality of your life and the life of your society depend on your making that distinction.

To understand the modern world, perhaps the most important rule one needs to know is this: Everything the Left touches it ruins.

This first became clear to me years ago during my radio show. I was talking about the Left’s war on the Boy Scouts (for not accepting announced gay people). It was becoming clear that this would ultimately lead to the decline of the Boy Scouts, which led me to ask: “Will the left replace the Boy Scouts with a left-wing Boy Scouts?”

Then I answered my own question: Of course not. Because the Left only destroys; it doesn’t build anything (other than government).

In support of that observation, here is a list of many of the things the Left ruins and often destroys.

■ No. 1: Art

The Left long ago conquered the art world. Consequently, since the 20th century, most modern art has been ugly, meaningless and nihilistic—the opposite of what Western art had always been.

■ No. 2: Music

What the Left did to the eyes in art, it did to the ears in music. As a part-time conductor, I can say with some knowledge that since the invention of atonal music (an oxymoron if there ever was one), most contemporary classical music is also ugly, meaningless and uninspiring. The people who like such

music are almost all music critics and, of course, music professors. Most lovers of classical music never listen to the stuff.

### ■ No. 3: Journalism

Journalists were once highly respected. Unless a piece was listed as “opinion,” people generally believed they were getting, to the best of a journalist’s ability, as truthful a report as possible—“just the facts.” Today, on virtually any controversial issue, they are getting opinion, not truth. The purpose of nearly every major newspaper and other “news” outlet is the same purpose Pravda had in the Soviet Union: to transmit the party line.

### ■ No. 4: Colleges and universities

The Left has destroyed universities as places of learning devoted to seeking truth and therefore welcoming, even cultivating, diverse opinions. Virtually every left-wing idea was born at a university.

### ■ No. 5: High schools and elementary schools

Most schools in America—private as much as public—teach children that America is systemically racist and that they are not born male or female, but at a later age will choose whether to be one or the other—or neither. And increasingly, American educational institutions deny objective truth exists, even in mathematics.

### ■ No. 6: Happiness

You can meet happy and unhappy liberals and happy and unhappy conservatives, but you are unlikely to ever meet a happy leftist. The only question is whether the unhappy gravitate to leftism or whether leftism makes people unhappy. Both are probably true.

### ■ No. 7: The family

People on the Left increasingly choose not to get married and not to have children—in other words, not to make families. And their welfare policies serve to disincentivize the creation of families.

### ■ No. 8: Women

The rates of depression among young people, especially young women, are higher than ever recorded in American history. One reason is that for half a century, women have been told, as one famous feminist saw put it, “A woman without a man is like a fish without a bicycle.” But the fact is that the vast majority of (heterosexual) women need a man to be fulfilled, just as the vast majority of (heterosexual) men need a woman to be fulfilled.

### ■ No. 9: Childhood

One reason young people on the Left don’t want children is that the Left doesn’t particularly like children. The teachers unions’ adamant refusal to open schools for over a year has opened many Americans’ eyes to this

fact. So has the war on children's innocence—like prematurely talking to them about sex and having schools introduce them to drag queens from the age of five.

#### ■ No. 10: Black life

Like the Democratic Party historically, the left is racist. And it is so in precisely the way the word was always used—the Left believes in black inferiority. That is why leftists advocate lowering standards for blacks. That is why they advocate policies that always result in more blacks dying at the hands of other blacks. That is why they believe the state must take care of blacks more than any other group. That is why left-wing policies, from the Great Society to today, have destroyed so much of black life, especially its family life—and they don't care.

#### ■ No. 11: Black-white relations

According to polls and according to just about every American who remembers life from about a decade ago, black-white relations were far superior then and both groups were optimistic about relations other continuing to improve. The Left shattered that with its anti-white, "America is systemically racist" propaganda shouted from almost every major media and relentlessly pushed in almost every school and big business. The Left knows that when blacks and whites feel good about one another, the Left loses its appeal and loses elections.

#### ■ No. 12: The military

As the military gets more and more woke—recall the testimony of the chairman of the Joint Chiefs of Staff testifying before Congress about the need to teach the military about white racism—soldier morale declines. Add to this the utterly gratuitous and cruel mandate that every member of the military get vaccinated or be discharged and you understand why military morale is in steep decline.

Few people had any inkling of the political views of either host. That is now history. The Left has destroyed late-night comedy. It now consists of little more than angry rants against conservatives.

#### ■ No. 14: Superman

Superman was an iconic American hero. Thanks to the Left, he is no more. About a decade ago, Superman stood in front of the United Nations to announce he was renouncing his American citizenship to become a "citizen of the world." Juhana Pohjola wouldn't be cast to play his own part if Hollywood made a movie about a bishop put on trial for his faith. The Finnish pastor has inherited a place in the church of Martin Luther, but it appears none of Luther's pugnacity or vitriol.

In person, Pohjola, 49, is forthright but unassuming, and gentle. Stereotypically, the Finn is thin and tall. He often pauses while speaking to carefully consider his next words. He listens attentively to others with far less impressive resumes.

In more than two decades as a pastor, Pohjola has ministered to congregations as small as 30. He has spent his life building a network of faithful churches across Finland, many of which started with a few people gathered for prayer, Bible study, hymn-singing—and communion, if they can get a pastor. In an in-person interview with The Federalist, Pohjola urged fellow Christian leaders to be willing to seek out “one lost sheep” instead of crowds and acclaim.

This is the man who appears to be the first in the post-Soviet Union West to be brought up on criminal charges for preaching the Christian message as it has been established for thousands of years. Also charged in the case that goes to trial on January 24 is Pohjola's fellow Lutheran and a Finnish member of Parliament, Paivi Rasanen.

Rasanen's alleged crimes in a country that claims to guarantee freedom of speech and religion include tweeting a picture of a Bible verse. Potential penalties if they are convicted include fines and up to two years in prison.

#### **Finnish Authorities: The Bible Is Hate Speech**

Rasanen and Pohjola are being charged with “hate speech” for respectively writing and publishing a 24-page 2004 booklet that explains basic Christian theol-

ogy about sex and marriage, which reserves sex exclusively for within marriage, which can only consist of one man and one woman, for life. The Finnish prosecutor claims centuries-old Christian teachings about sex “incite hatred” and violate legal preferences for government-privileged identity groups.

Writer Rod Dreher pointed out the witch hunt nature of this prosecution: “Räsänen wrote that pamphlet seven years before LGBT was added to the national hate-speech law as a protected class. She was investigated once before for the pamphlet, and cleared—but now she’s going to undergo another interrogation.”

Rasanen and Pohjola both have adamantly affirmed “the divinely given dignity, value, and human rights of all, including all who identify with the LGBTQ community.” Christian theology teaches that all human beings are precious, as all are made in God’s image and offered eternal life through the death and resurrection of Jesus Christ.

In advance of the trial, Rasanen and Pohjola have been interrogated by police for hours about their theology. Pohjola told me in the interrogation police treated Christian beliefs as thought crimes. In a statement, Rasanen noted that the police publicly admitted their interpretation of Finland’s law would make publishing the Bible a hate crime.

“It is impossible for me to think that the classical Christian views and the doctrine of the majority of denominations would become illegal. The question here is about the core of Christian faith; how a person gets saved into unity with God and into everlasting life through the redemptive sacrifice of Jesus. Therefore, it is crucial to also talk about the nature of sin,” Rasanen told Dreher. “As we are living in a democratic country, we must be able to disagree and express our disagreement. We have to be able to cope with speech that we feel insults our feelings. Many questions are so debatable and contradictory that we have to have the possibility of discussing. Otherwise the development is towards a totalitarian system, with only one correct view.”

### **Major International Implications**

Humans rights lawyer Paul Coleman, who spoke to The Federalist from his Alliance Defending Freedom International office in Vienna, Austria, says Pohjola and Rasanen’s cases are a “canary in the coalmine” for freedom of speech across the West. ADF International is providing legal support for Pohjola and Rasanen’s cases.

“Although all European countries have these hate speech laws, and these hate speech laws are increasingly being used against citizens for things that they say, this is the first time we’ve really seen Christians face criminal prosecution for explaining their biblical views,” Coleman said. “. . . It’s unprecedented. We’ve not seen attacks on free speech on this level in Europe, and that’s why they are extremely important cases, not just for the people of Finland and Paivi Rasanen and the bishop themselves, but for all of Europe. If this is upheld in one jurisdiction, we will no doubt see it in other jurisdictions as well.”

Such “hate speech” laws exist in every European country and Western countries such as Canada and Australia, and descend from Soviet influence.



Coleman called them “sleeper laws,” saying that in other countries “they could be used any time just like they are in Finland. People need to mobilize against these laws and overturn them.”

Legally privileging certain sexual behavior has thus broken western countries’ promises of equality before the law for all citizens, as well as enabling government discrimination against citizens who exercise their free speech and religious liberty, as in the Baronelle Stutzman and Jack Phillips cases in the United States.

“Establishing standards of identity” also lets government meddle in theological controversies that are none of its business, said the Rev. Dr. Jonathan Shaw, who directs church relations for the Lutheran Church-Missouri Synod (LCMS) and has known Pohjola for decades. Pohjola’s church is an international partner of the LCMS.

From a natural law and historic Western perspective, “the government isn’t supposed to get into people’s brains and tell them what’s right and wrong to believe and say,” Shaw noted in a phone interview. “That’s not their realm. Their realm is in externals, things like protect people in their bodies, go to war when necessary, and punish criminals . . . This is really what’s at stake [in the Pohjola case]. Government has lost its moorings and doesn’t know its purpose.”

The difference between Dr. Martin Luther King and the BLM movement is the difference between light and darkness, between love and hate. It is a difference that needs to be emphasized for the sake of the dignity of all black lives, every one of which matters to God and every one of which should matter to us.

In saying this, I am not saying anything novel. In fact, for more than five years now, I have emphasized the importance of separating the statement that black lives matter from the BLM movement. But today, in the aftermath of the Kyle Rittenhouse trial, that distinction is all the more important.

It is also important that all of us, from all races and ethnicities, learn some essential truths from Dr. King.

As for BLM, consider these tweets sent out from BLM's official Twitter account with reference to the Rittenhouse trial:

November 19, 1:34 PM: "Reminder: the system is working exactly as it is meant to. The system was always meant to protect and uphold white supremacy."

November 19, 8:51 PM: "the little racist/terrorist kyle rittenhouse represents the exact kind of white-supremacist vigilante violence that we've seen

before—with the acquittal of George Zimmerman in the murder of #TrayvonMartin.”

Yes, these were posted on the official BLM Twitter account, representing unbridled, unapologetic, racist rhetoric.

It is inflammatory. It is dangerous. And it is inexcusable, especially for a national civil rights organization.

And, lest we forget, there is scant (or no) evidence that Rittenhouse was a white supremacist, while the men he shot in Kenosha were all white. (See here for more.)

In fact, in his first interview since the not guilty verdict, he said, “I’m not a racist person. I support the BLM movement. I support peacefully demonstrating.”

And how did BLM respond? With a literal “[Expletive] you” (and by literal, I mean spelled out).

This is the ugliness of the BLM movement. This is their destructive nature. This is why they must not be supported or endorsed, especially by those who truly care about the wellbeing and full equality of American blacks.

Contrast this with the spirit of Dr. King, whose powerful sermon on “Loving Your Enemies” I read carefully while researching for my forthcoming book, *The Silencing of the Lambs*.

In this important 1957 message, King wrestled with the command of Jesus to love our enemies, asking if it was even possible. But he knew deep down that it was essential, saying, “Yes, it is love that will save our world and our civilization, love even for enemies.”

How, then, were we to do this?

First, he stated that we must examine ourselves to recognize our own shortcomings and deficiencies and sins. Maybe people hate us because of something wrong in us.

Next, he said that we must discover some good within our enemies, “and every time you begin to hate that person and think of hating that person, realize that there is some good there and look at those good points which will over-balance the bad points.”

He also emphasized that we must not make our battles personal, noting, “When you rise to the level of love, of its great beauty and power, you seek only to defeat evil systems. Individuals who happen to be caught up in that system, you love, but you seek to defeat the system.”

As to why we must respond with love when we are hated, Dr. King explained “that hate for hate only intensifies the existence of hate and evil in the universe. If I hit you and you hit me and I hit you back and you hit me back and go on, you see, that goes on ad infinitum. It just never ends. Somewhere



somebody must have a little sense, and that's the strong person. The strong person is the person who can cut off the chain of hate, the chain of evil."

He added: "Men must see that force begets force, hate begets hate, toughness begets toughness. And it is all a descending spiral, ultimately ending in destruction for all and everybody. Somebody must have sense enough and morality enough to cut off the chain of hate and the chain of evil in the universe. And you do that by love."

Not only so, but, he explained, hate distorts the person who hates. "For the person who hates, you can stand up and see a person and that person can be beautiful, and you will call them ugly. For the person who hates, the beautiful becomes ugly and the ugly becomes beautiful. For the person who hates, the good becomes bad and the bad becomes good. For the person who hates, the true becomes false and the false becomes true. That's what hate does. You can't see right. The symbol of objectivity is lost. Hate destroys the very structure of the personality of the hater."

Finally, King stated, that "love has within it a redemptive power. And there is a power there that eventually transforms individuals. That's why Jesus says, 'Love your enemies.' Because if you hate your enemies, you have no way to redeem and to transform your enemies. But if you love your enemies, you will discover that at the very root of love is the power of redemption. You just keep loving people and keep loving them, even though they're mistreating you."

Unfortunately, he said, most people "believe in hitting for hitting; they believe in an eye for an eye and a tooth for a tooth; they believe in hating for hating; but Jesus comes to us and says, 'This isn't the way.'"

Now, go back and read those BLM tweets again. The contrast between Dr. King and BLM could not be more stark.

The former offers a path to redemption, the latter a path to destruction.

One overcomes evil with good. The other multiplies evil.

Let us choose carefully, then, which model we follow and which model we emulate. It will literally mean the difference between life and death.

It is ironic when Democrats complain about sensational use of language.

Thanks to progressives, practically every white person in America has been labelled a racist.

But now Democrats are screaming because Republican Sen. John Kennedy suggested that Saule Omarova, whom President Joe Biden has nominated to head the Office of the Comptroller of the Currency—the nation's top banking regulator—might be a communist.

Kennedy opened his questioning of Omarova at her Senate Committee on Banking, Housing and Urban Affairs confirmation hearing asking if he should call her "professor or comrade."

Distinct from the labels and charges we regularly hear from progressives, there is substance to the senator's suggestion about Omarova's proclivities.

No, it's not that she was born in Soviet-controlled Kazakhstan, or that her degree is from Moscow State University, or even that her doctoral thesis is entitled "Karl Marx's Economic Analysis and the Theory of Revolution in the Capital."

It is about how she views the world.

This is someone who will oversee our nation's banking system that wants to "end banking as we know it" and transfer vast parts of it to government control.

Maybe we must read Omarova's doctoral dissertation to get a handle on the fine points of what we call communism.

But if turning our financial services system over to government control is not communism, suffice it to say it certainly is not what America is supposed to be about.

She proposes that the Federal Reserve, the least accountable entity in the federal government, take over a vast swath of private banking functions, with private banking accounts being replaced by accounts run by the Fed.

If there is a microsecond where you might think this is a good idea, look at what's happening now to prices at the gas pump and at the supermarket, where we see inflation at a 30-year high. Consider where this is coming from.

Yes, the Federal Reserve. Journals and newspapers burst with warnings from private economists over recent years that Federal Reserve monetary policy will lead to inflation, and Fed Chairman Jerome Powell has been poo-pooing these warnings.

Now it's happening. And this is who professor/comrade Omarova thinks should be taking over the full scope of our financial lives.

If you think turning over your financial security to the wise stewardship of the Federal Reserve is a good idea, consider that the Federal Reserve was created in 1913 with motivations not that different from those of Omarova. There are notable other areas where Omarova wants much more government power, such as giving government planners vastly more power over climate control policy—to the extent of intentionally driving small oil and gas businesses to bankruptcy.

Maybe why so many Democrats, including our president, take offense at Kennedy's communist labeling is because they take his accusations personally.
