Gavin Forrestier had successful surgery on Friday. For background information, here is an excerpt of a description of the surgery that **Clay** gave on Dec. 19: "He will have two surgeons for the tumor and one surgeon for the facial nerves. They will also be making an incision near his belly button to remove fat and to graft into the crevice left from the tumor removal." Following is an excerpt after the surgery on Friday afternoon: "The surgery didn't take as long as expected. The tumor was not embedded in facial nerves, which made the procedure a lot less complicated. They did not have to do a fat graft. The indention is minimal, and he should grow out of it in time. He is in recovery, and the surgeon said he did great. We are waiting to see him now."

"Philippians 4:13-Part 3"

BIG SANDY, Texas—At our Bible study on Wednesday night, I continued with a series about Philippians 4:13. This was part 3.

Philippians 4:13—"I can do all things through Christ who strengthens me."

Reasons for choosing

Why would a pastor give a Bible-study series about the words found in Philippians 4:13?

Here are four of my thoughts.

- I believe that a merciful Heavenly Father readily answers prayers.
- But I do not believe in the "name it, claim it" approach—where people can push God to do what they want Him to do and cause Him to submit to them.
- Our loving Father gives us so much—every need and many of our wants.
- One of the greatest gifts a dad gives to his children is a can-do, positive attitude, and the perfect Heavenly Father does the same—He helps us to succeed in times of adversity.

Every need and some desires

In a recent study, I discussed two approaches of our Heavenly Father.

- 1. I believe that God (as a perfect Father) will supply our personal needs—because He is trustworthy and because He loves us.
- 2. I believe that God will often give us the desires of our heart—because He loves us.

Sometimes says "no"

In last Wednesday's study, I mentioned a third approach of our Heavenly Father.

3. I believe that God sometimes says "no" to our requests (often the desires of our heart)—because He loves us.

I organized this third concept in three specific points.

God is not controlled by prayer

Let me show you some scriptures that

confirm that God is not controlled by the prayers of His children.

- Jeremiah 7:16—The Lord told the people not to pray for this particular group of people—saying that, if they made intercession to Him, He would not hear their prayer for those people.
- Jeremiah 11:14—The Lord told the people not to pray for this particular group of people.
- Jeremiah 14:11-12—The Lord told the people not to pray for good things for this particular group of people—saying that He would not accept their fast.
- Exodus 4:21-23—The Lord told Moses that He was going to harden Pharaoh's heart—revealing that He sometimes micromanages a situation (and may not be influenced by prayer requests).
- Romans 9:18—The apostle Paul mentioned the Exodus history to show that sometimes God micromanages a situation (and may not be influenced by prayer requests).
- Revelation 6:11—The book of Revelation shows that some events are preordained (and may not be influenced by prayer requests).

God doesn't give foolish things

- James 4:2—Some people don't receive answers because they don't ask.
- James 4:3—Some people don't receive answers because they ask amiss.

God teaches lessons

- Deuteronomy 3:23-27—The Lord told Moses "no"—because of Moses' behavior (whether a sin or merely a mistake).
- 2 Samuel 12:15-23—The Lord told David "no"—because of David's sin (even though David was fasting when he made his request).
- 2 Corinthians 12:7-9—The Lord told Paul "no"—because He was going to show His strengthen through Paul's humanity.
