Prayer updates

As was announced orally last Saturday, **Eli Benedict** went by ambulance on that afternoon to the Good Shepherd Medical Center in Longview due to swelling in his left leg. He was diagnosed with cellulitis. The doctors did an ultrasound, which ruled out blood clots. He was about to return home on Tuesday. **Jean** reports that he has been getting around the house well using his walker. Now we will see if this recent incident affects Mr. Benedict's appointment on March 20 for a CAT scan and a cystoscopy (for the bladder).

In last week's bulletin, we mentioned that **Sonny Rosenberger** was scheduled last Tuesday for a procedure called a UroLift (a treatment to help men with prostate challenges). We also mentioned that Mr. Rosenberger has had his patience tested because this procedure had been scheduled and postponed several times (beginning last August). It happened again. The procedure was postponed until March 19.

On Wednesday, **Betty Foster** (who continues to rehab at Legend Oaks Nursing Home in Gladewater) went to the orthopedic doctor, who removed the brace. After she spends some time getting around without the brace, she expects to go home. However, she reported that a pain (unrelated to the removal of the brace) has slowed her progress. She is in Room 307.

Ron Feaker continues to rehab at the home of caregiving daughter Karen.

Elaine Holloway continues to rehab at Legend Oaks Nursing Home in Gladewater. She is in Room 109.

Marilyn Boston continues to rehab at Park Place Rehabilitation Center in Tyler (2450 E. Fifth St.). She is in Room 218.

Following are excerpts from **Jeff Ledy** of Michigan on March 4 about his son **Eric Ledy** of Austin: "I'm writing from Austin. I flew down Saturday [March 2] to join [wife] **Sharon** and **Eric.** The past two months have been a roller coaster of emotions for all of us. Wednesday night [Feb. 27] we got the results from a CT scan they did here in Austin of his chest and abdomen. The results were devastating to us. Eric has multiple new cancer nodules throughout his chest the size of marbles, a tumor larger than an egg in his left lung, and a three-inch by two and one-half inch rapidly growing tumor on his left shoulder blade. It is now visible in its location and size. It is also starting to cause him pain in his shoulders and neck. As a result of this change in condition, Eric has decided to undergo chemotherapy. It is still hard to comprehend how ill he is on the inside because he acts and looks healthy on the outside. Eric is in remarkably good spirits now that we have had a couple of days to accept the results of the recent CT scan. We are hopeful and prayerful, and thank you for being there assisting us along the way."

In last week's bulletin, we mentioned that **Chuck Ragland** (father of **Diana Havir**) was transported to Baylor Hospital in Dallas, where a colorectal specialist was examining his condition. (The family wanted to exhaust curative options before accepting comfort alternatives.) The medical team there is considering some possibilities of treatment.

"Meditate on Whatever Is a Virtue"

BIG SANDY, Texas—Here is one of the best pieces of advice that a mental-health professional can give to people: "Focus upon the positive factors of this life." It should come as no surprise that this concept is found in the Bible.

One verse that promotes this approach is Philippians 4:8.

Philippians 4:8—"Finally, brethren, whatever things are true, whatever things are noble, whatever things are just, whatever things are pure, whatever things are lovely, whatever things are of good report, if there is any virtue and if there is anything praiseworthy—meditate on these things."

We began a series to talk about the characteristics mentioned in this verse. Today, we will talk about things that are "a virtue."

Recognize negative

Before we look at this week's characteristic, I want to remind you about a realistic approach in life—recognize negative, but dwell on positive.

- Numbers 13:26-33—Although the other spies became preoccupied with the negative factors, Joshua and Caleb recognized the challenges and focused upon God's promises.
- Luke 14:26-33—The Son of God's instruction to count the cost includes recognizing the challenges and focusing upon God's promises.

Greek word in Philippians 4:8

Let's notice the Greek word used in Philippians 4:8.

Arete (No. 703 in Strong's Concordance) is the Greek adjective in Philippians 4:8 translated as "virtue." It is used four other times in the New Testament.

1 Peter 2:9—"But you are a chosen generation, a royal priesthood, a holy nation, His own special people, that you may pro-

claim the praises of Him who called you out of darkness into His marvelous light."

- 2 Peter 1:3—"As His divine power has given to us all things that pertain to life and godliness, through the knowledge of Him who called us by glory and virtue."
- 2 Peter 1:5—"But also for this very reason, giving all diligence, add to your faith virtue, to virtue knowledge."

Other translations

Here are a few other examples about how *arete* is translated in other Bible translations.

- The New Testament in Modern Speech (Richard Francis Weymouth)—"if there is any virtue"
- The Berkeley Version of the New Testament—"whatever is lofty"
- Revised Standard Version—"if there is any excellence"
- New American Standard Bible—"if there is any excellence"
- James Moffatt Translation—"all excellence"

Any excellence

Although the word *arete* is not used in the following verses, let's notice a few scriptures about the concept of excellence.

I Corinthians 12:31—"But earnestly desire the best gifts. And yet I show you a more excellent way."

Philippians 1:10—"That you may approve the things that are excellent, that you may be sincere and without offense till the day of Christ."

Hebrews 1:4—"Having become so much better than the angels, as He has by inheritance obtained a more excellent name than they."

Hebrews 8:6—"But now He has obtained a more excellent ministry, inasmuch as He is also Mediator of a better covenant, which was established on better promises."
