In the June 15 bulletin, we mentioned that **Gary Wilson** was going again to Metairie, La. to receive additional hyperbaric therapy. He is scheduled to return home next Friday and is looking forward to seeing his friends at our church service.

In last week's bulletin, we mentioned that **Melodee Eishen** had an immediate positive reaction to her surgery on Friday, July 5. However, she began to encounter a few difficult days with pain, nausea and violent vomiting. She began feeling better on Monday and returned home on Wednesday.

In last week's bulletin, we mentioned that **Timberly Dunnam** had an MRI and is expecting to find out the results of the test on July 18. We heard about another trial that she deals with – she has developed many allergies, so the family is looking to talk with a specialist in Dallas about the matter. She would appreciate your prayers.

In last week's bulletin, we mentioned that **Angela Dunnam** had hurt her knee while being stung 14 times by wasps and that she was hoping to see an orthopedic surgeon. She has temporarily postponed her treatment to focus upon the needs of **Timberly**.

On Tuesday, **Dixon Cartwright** had his surgery to receive an enhanced stent in his neck. After the surgery, he was experiencing low blood pressure and a low heart rate. The doctor recommended for Mr. Cartwright to receive a pacemaker – which was inserted on Friday morning.

In last week's bulletin, we mentioned that **Randy Searer** of Kalmath Falls, Oregon (brother of **Mark Searer**) had surgery after being diagnosed with an abscess of his colon (causing leakage into his lower intestine) and the surgeon inserted a stent into the abscess for draining. He is talking clearly now and he was able to stand up and sit in a chair for the first time in six days. We are so thankful for everyone's prayers."
