If you listen to the liberal media, it's Berlin 1933 all over again, or perhaps Moscow 1937, or maybe Madrid 1939.

The liberals are literally wetting their pants, with hysterical cries that American democracy is under the imminent threat of a fascist dictatorship. And of course, that fascist dictator would be none other than President Donald Trump.

Senators complainmmmm

- Reacting to Trump's speech about mobilizing the military to protect our cities from lawless rioting and looting, California Senator Kamala Harris had this to say: "These are not the words of a president. They are the words of a dictator."
- And Oregon Senator Ron Wyden is heading to the barricades to protect American democracy from mean ole' Fascists: "The fascist speech Donald Trump just delivered verged on a declaration of war against American citizens. I fear for our country tonight and will not stop defending America against Trump's assault."

So, this is it, The End Of America's Democratic Experiment, the moment the lights went out in the City Upon a Hill.

Actual dictatorships

Well, let me assure you that American democracy is alive and well. And understanding this essential fact is easier if you look at some real, actual dictatorships.

I like to think I have some idea of what dictatorship actually looks like as I have spent quite a bit of time in countries that are ruled by undeniably dictatorial regimes, such as Uzbekistan, Belarus, Turkmenistan, Syria, Burma, and China.

I've also spent time in countries that are run by authoritarian quasi-dictatorships like Russia, Kazakhstan, and Venezuela.

In fact, I spent four years working in Russian state media and saw from the inside how such a regime operates.

Uzbekistan is one of my favorite countries in the world. Samarkand and Bukhara were once important outposts on the famed Silk Road from Europe to China, and their architectural heritage is nothing short of stunning.

Uzbek cuisine is equally stunningly delicious. And Uzbeks themselves are some of the friendliest and most hospitable people you'll ever meet.

Anything but free

After the break-up of the Evil Empire, Uzbekistan gained independence. But its people have been anything but free. Former Communist Party boss Islam Karimov won the first ever presidential election in 1991, and was re-elected in 2000, 2007 and 2015 in blatantly rigged elections, each time with more than 90% of the purported vote.

All real opposition parties have been outlawed, their leaders in prison, in exile, or dead. Until his death in 2015, Karimov ruled Uzbekistan for more than 23 years as an absolute tyrant.

A United Nations report described the following.

- Torture by the authorities was "institutionalized, systematic, and rampant."
- The police and security services routinely kidnapped and murdered opposition figures; rape of prisoners was common.
- It is widely rumored that some prisoners were boiled to death.

In 2005, there were widespread protests in the city of Andijan. Police closed all exits from Bobur Square in the city center and deliberately drove the protesters into a trap.

An estimated 800 people were killed by snipers and machine-gun fire.

When I was there in 2007, I knew it was a dangerous topic to discuss. But when I simply asked people, 'Excuse me, how do it get to Bobur Square?' I could see raw fear in their eyes.

No free media

There are no free media.

In fact, when I was there, I could find only one newspaper distributed in the whole country, four pages daily, and mostly devoted to stories extravagantly praising Karimov, one I remember was headlined "President Karimov Receives Phone Call From Ambassador of Qatar."

There are several TV channels, all under government control, and all were dedicated to proclaiming Karimov the best president ever in world history. The internet is strictly regulated, and all websites critical of the regime are blocked. Even private conversations may be monitored for any signs of dissent.

Belarus is much less interesting, except that its capital Minsk is the most perfect example of a city built almost entirely in the Stalinist style of architecture.

Continuous president

Alexander Lukashenko was elected president in that country's first and only free elections in 1994. Since then he has been re-elected in 2001, 2006, 2010, and 2015, always with 80% to 84% of the vote.

I was in Minsk on the eve of the 2010 election. Protests were expected against his one-man rule, mostly peaceful. As I walked around the city's "Independence Square" around dusk, I noticed dozens of buses carrying the fearsome and widely feared OMON (Special Purpose Mobile Police).

Praetorian Guard

These riot police are Lukashenko's Praetorian Guard, loyal only to him and completely beyond any civilian control. And these guys were clearly amped up, already fidgeting with their riot shields and heavy batons, obviously eager to get out and start bashing heads in. Knowing what they were capable of, and not feeling especially heroic, I decided to wait out the rest of the night in the relative safety of my hotel room.

The next day the Central Election Commission dutifully proclaimed Lukashenko the winner with the predictable 80% of the vote (most post-Soviet leaders are elected with around 80%, to seem like an overwhelming victory, but not so overwhelming as to be farcical).

The OMON had arrested hundreds of protesters the night before, many severely beaten. Seven of the main opposition leaders were arrested by the KGB (yes, they still call it that) the day after the election, and an eighth was found dead, officially deemed a "suicide."

Not even close to a dictatorship

So, what does a real dictatorship look like?

Presidents-for-life, elected over and over again in sham elections.

Opposition parties outlawed, and dissidents harassed, imprisoned, tortured, and murdered, or merely exiled if they're lucky.

All media under state control, and all access to opposition views blocked.

Ordinary citizens cowed into submission by police and security services who stand above and beyond any laws.

Plus, rubber-stamp legislatures who allow the dictator to rule by personal fiat, and judicial systems unable and unwilling to defy their employers, who are not the people but their rulers.

Now, as far as I know, Senators Harris and Wyden, as well as former Vice President Biden and the Clintons are not rotting in jail cells in secret prisons.

Stephen Colbert, Chris Hayes, and Don Lemon are still on the air.

Democrats still get elected to office, and Congress does not do Trump's bidding merely at his command.

The *New York Times* and *Washington Post's* websites were still functioning last time I checked this morning, and neither paper was devoted to lavishly praising President Trump.

Labels to scare

In short, Donald Trump is not a dictator, or a fascist. But liberals are desperate to tar him with these brazenly false labels.

"Dictator" and "fascist" are boogie-man words designed to scare people into believing that Trump is a threat to their liberty and freedom, and the only way to save American democracy is to vote for Democrats.

It's downright shameful, and it shows their pathetic ignorance of basic reality. We need to fight their lies with the truth.

Iran may be preparing for conflict with Israel in Syria and no longer will accept Israeli airstrikes on its warehouses without a response, a report over the weekend suggested. Veteran journalist Elijah Magnier wrote on the website Medium about whether the "great Middle Eastern war will begin in the Levant" and cited Syria as a potential flashpoint.

Magnier's report is interesting because he asserts that according to "private" sources, Iran is evacuating "sites of the gatherings of its advisers, not for withdrawal or for redeployment, but to find bases within the Syrian Army barracks. Hezbollah has taken over the vacated Iranian buildings. Russia has been informed of the change so that the information would reach Israel."

In mid-May, reports emerged that Iran might be withdrawing some of its forces from Syria, estimated at some 1,000 IRGC personnel. But analysts and US officials rejected this assessment at the time.

The June 6 piece by Magnier provides another view as to what may be happening: "Iran no longer wants to accept Israeli strikes on its warehouses without any response."

An airstrike killed nine Iranian-backed forces in Syria, Radio Farda reported over the weekend. This report also said there were explosions near Masyaf, a Syrian-regime and Iranian facility that has been hit by airstrikes in the past. That airstrike may have taken place on June 4.

Another airstrike, blamed on Israel, was reported overnight on June 7 in the morning. The Syrian Observatory for Human Rights said some eight warheads fired by "unidentified drones" hit an area near Deir Ezzor. The targets were Afghan and Iraqi Shi'ite militias at the "Meizileh base," reports said.

Iran has been moving its advisers, which Magnier says number a few hundred, to Syrian-regime bases. This would protect them ostensibly because airstrikes would be less likely to hit them there. If there were airstrikes, then the Syrian regime would respond, and this "would most likely drag the US into the battle to support its ally Israel and have an impact on the forthcoming elections," Magnier wrote.

Russia plays a key role because it is coordinating with Israel, he wrote, adding: "It was agreed between Israel and Russia that Moscow and [Russia's airbase at] Khmeimim would be informed of the details of any strike."

Russia plays the middleman, in this view, not part of Iran's "axis of resistance," but telling its Syrian-regime allies what is happening.

"Russia has informed Israeli leaders of this move by Iranian advisers and their presence among the Syrian army units," Magnier wrote.

"Russia warned Israel not to strike the Syrian army under any circumstances and informed them that the Iranian bases have been handed over to Hezbollah."

Hezbollah's special-operations units, Radwan (Al-Ridwan), have not lost a battle in Syria, he wrote. However, the unit did suffer a setback at the hands of Turkey in Idlib in February and March, The Jerusalem Post reported on May 21.

Magnier's article has a larger point. Hezbollah takes seriously the killing of its fighters, he wrote, adding: "Israel's drones make sure these locations are free of Iranian advisers and that the Russian warning reaches those concerned to evacuate human personnel . . . Israel follows the same practice when it attacks Hezbollah cars or trucks, warning drivers and passengers in advance."

Warning missiles are fired, the report said.

But after an incident in Beirut in August 2019 involving drones, Hezbollah sought to retaliate, and it wants to show it has deterrence.

Hezbollah has stockpiled missiles and precision guidance and “drones, land-attack long-range all-weather subsonic cruise missiles . . . long-range anti-ship missiles” and other munitions, Magnier wrote.

Hezbollah believes it has a deterrent and “new rules of engagement” that protect its men in Syria. Nevertheless, wars can start by mistake, the article concludes.

US Special Forces have been pictured training in Syria with the Israeli-made Smart Shooter SMASH 2000 sighting system mounted on their M4A1 carbines.

“Coalition Forces zero Smart Shooter sighting devices during a familiarization range near al-Tanf Garrison, Syria,” read one caption to the photo published to the Defense Visual Information Distribution Service (DVIDS) on May 30.

“Coalition and partner forces regularly train on various weapon systems in a joint effort to help set conditions for the enduring defeat of Daesh [ISIS] in Syria.”

According to Task and Purpose, United States Special Operations Command purchased 98 SMASH 2000 systems from Smart Shooter in March 2019 “to evaluate the capability in an operational environment.”

The system, which is fully developed, manufactured and produced in Israel by Smart Shooter, has been in use by the IDF and available to international forces around the world, with the main customer being the US Special Forces.

Dr. Abraham Mazor, VP BD & Marketing of Smart Shooter told The Jerusalem Post that it was the first time that the company was aware of the fact that the system is in use by customers operating in Syria.

“The US Special Forces bought the system to use in real combat situations,” he said, explaining while the US military for obvious reasons won’t share when and where the system is used “we are proud that the US armed forces appreciate the performance of the system.”

The system is “100% SMARTSHOOTER” Mazor told the Post. The company “is in direct communication” with the United States Special Operations Command (SOCOM), working with them for US Special Forces and the IDF.

“We are proud of this connection,” he said. “We are proud of any of our products that work for increased survivability and safety of the US and Israeli forces.”

Last August the US Air Force tested the cutting edge fire control system at the Beale Air Force Base in California but this seems to be the first time troops have used the system in the war-torn country where troops continue to face threats from ISIS.

In the photos, troops are seen using the system to fire at a box carried by a drone, a known tactic used by IS terrorists against coalition forces.

While the drones and other incendiary aerial devices are cheap and usually toys that can be bought on the civilian market, they are fast and remain a challenge even for skilled sharpshooters.

Like many militaries across the world, the US has been testing various counter-drone systems in combat zones. The SMASH 2000 gives troops a precision anti-drone system on their weapon with built-in targeting algorithms that can track and hit drones flying at high speeds at ranges of up to 120 meters with the first shot.

With the system, the user selects and locks onto the target. As soon as the trigger is squeezed, the system calculates the target's movement and predicts its next location using advanced image processing and algorithms. SMASH 2000 prevents the bullet from being fired until the target is precisely in its cross hairs.

The SMASH 2000 fire control system has been using innovative technologies to help militaries and other security or law enforcement agencies accurately neutralize moving targets. It has a built-in storage system allowing for videos and images to be recorded for training and debriefings.

President Donald Trump is taking heavy criticism for his announcement on Friday [May 29] that the U.S. is "terminating its relationship with the World Health Organization."

But the evidence is mounting that the \$450 million the U.S. spends yearly on WHO is money down a rat hole.

On Monday, the Associated Press revealed how the WHO lied to the world about China's initial cover-up of the coronavirus outbreak. Those lies, which delayed other countries' responses to the virus, caused hundreds of thousands of needless deaths.

The AP gained access to recordings of internal WHO meetings in January. Those recordings capture WHO officials discussing how to keep China's secretive conduct under wraps, even as WHO kept praising China publicly. That sugarcoating left the world unaware and unprepared for the pandemic about to hit.

Even without this damning new information, Trump would have been right to pull American dollars and prestige out of the WHO. The organization has an abysmal record dealing with previous global diseases, from SARS to H1N1 flu and Ebola.

In the aftermath of the Ebola outbreak in 2014, Harvard Global Health Institute Director Ashish Jha wrote of the growing skepticism toward the WHO because it "often fails to perform when the world needs it most."

Look at how WHO spends its money. Only 4% goes for medical supplies. Double that is spent on air travel, and 10 times that on staff salaries and perks. WHO is a bloated, cushy bureaucracy.

Don't confuse WHO with the American Red Cross, Doctors Without Borders or other organizations delivering care to the sick. On Sunday, Trump's national security adviser Robert O'Brien suggested the U.S. will shift its support to such front-line care.

WHO spends hundreds of millions of dollars a year hosting meetings, paying for business class travel and top hotels, and turning a blind eye when senior staff go "with girlfriends on fabricated missions," according to an AP investigation.

Why should U.S. taxpayers, who kick in \$450 million a year, the most from any nation, pay for global junkets?

In the AP's latest revelations, WHO's top staff are recorded discussing behind closed doors how China is concealing the virus, while publicly praising China for transparency.

China had mapped the genetic makeup of the virus by Jan. 2 but withheld the information until Jan. 11. Worse, it concealed until Jan. 20 that the virus is contagious, even though Wuhan hospitals were flooded with patients. By the time China locked down Wuhan, some 5 million residents had fled, carrying the disease across the world.

"It's obvious that we could have saved more lives and avoided many, many deaths if China and the WHO had acted faster," explains the University of Washington's Ali Mokdad.

Yet, WHO Director-General Tedros Ghebreyesus whitewashed China's deception.

"The speed with which China detected the outbreak, isolated the virus, sequenced the genome, and shared it with WHO and the world are very impressive and beyond words," Tedros announced on Jan. 30. He called it a "new standard of outbreak response."

The communist standard—lie and let hundreds of thousands die. The same thing happened when China tried to hide SARS in 2003.

When Trump suspended WHO's funding in April, Tedros pompously lectured: "Don't use this virus as an opportunity to fight against each other or score political points." Tedros needs to look in the mirror.

He's the one playing politics, barring Taiwan from participating in two emergency coronavirus meetings. Taiwan had some of the earliest cases and was the first to tip off the WHO that the coronavirus was likely contagious. But any concessions to Taiwan infuriate Beijing, and that's where Tedros's loyalty lies.

House Speaker Nancy Pelosi claims the president, without Congress's approval, doesn't have the constitutional authority to hold back WHO funding or pull the U.S. from the organization. Let the lawyers haggle over that.

Trump's got the big picture.

WHO is not worthy of U.S. support.

WHO puts politics ahead of the world's health and blows our tax money on travel boondoggles and high living for its staff.

While it might not be popular to say in the wake of the recent social disorder, the true plight of black people has little or nothing to do with the police or what has been called “systemic racism.”

- Instead, we need to look at the responsibilities of those running our big cities.

Some of the most dangerous big cities are: St. Louis, Detroit, Baltimore, Oakland, Chicago, Memphis, Atlanta, Birmingham, Newark, Buffalo and Philadelphia. The most common characteristic of these cities is that for decades, all of them have been run by liberal Democrats. Some cities—such as Detroit, Buffalo, Newark and Philadelphia—haven’t elected a Republican mayor for more than a half-century.

On top of this, in many of these cities, blacks are mayors, often they dominate city councils, and they are chiefs of police and superintendents of schools.

In 1965, there were no blacks in the U.S. Senate, nor were there any black governors. And only six members of the House of Representatives were black.

As of 2019, there is far greater representation in some areas—52 House members are black.

Nine black Americans have served in the Senate, including Edward W. Brooke of Massachusetts, Carol Moseley Braun and Barack Obama of Illinois, Tim Scott of South Carolina, Cory Booker of New Jersey, and Kamala Harris of California.

In recent times, there have been three black state governors.

■ The bottom line is that today's black Americans have significant political power at all levels of government. Yet, what has that meant for a large segment of the black population?

Democratic-controlled cities have the poorest-quality public education despite their large, and growing, school budgets.

Consider Baltimore, Maryland. In 2016, in 13 of Baltimore's 39 high schools, not a single student scored proficient on the state's math exam. In six other high schools, only 1% tested proficient in math. Only 15% of Baltimore students passed the state's English test.

That same year in Philadelphia only 19% of eighth-graders scored proficient in math, and 16% were proficient in reading.

In Detroit, only 4% of its eighth-graders scored proficient in math, and 7% were proficient in reading. It's the same story of academic disaster in other cities run by Democrats.

Violent crime and poor education is not the only problem for Democratic-controlled cities.

Because of high crime, poor schools and a less pleasant environment, cities are losing their economic base and their most productive people in droves.

When World War II ended, the population of Washington, D.C., was about 800,000; today, it's about 700,000. In 1950, Baltimore's population was almost 950,000; today, it's around 590,000. Detroit's 1950 population was close to 1.85 million; today, it's down to 673,000.

The population of Camden, New Jersey, in 1950 was nearly 125,000; today it has fallen to 74,000.

St. Louis' 1950 population was more than 856,000; today, it's less than 294,000. A similar story of population decline can be found in most of our formerly large and prosperous cities. In some cities, the population decline since 1950 is well over 50%, and that includes Detroit, St. Louis, Cleveland and Pittsburgh.

Academic liberals, civil rights advocates and others blamed the exodus on racism—"white flight" to the suburbs to avoid blacks.

But blacks have been fleeing some cities at higher rates than whites.

The five cities whose suburbs have the fastest-growing black populations are Miami, Dallas, Washington, Houston and Atlanta.

It turns out that blacks, like whites, want better and safer schools for their kids and don't like to be mugged or have their property vandalized. And like white people, if they have the means, black people cannot wait to leave troubled cities.

White liberals and black politicians focus most of their attention on what the police do, but how relevant is that to the overall tragedy?

According to Statista, this year, 172 whites and 88 blacks have died at the hands of police.

■ To put police shootings in a bit of perspective, in Chicago alone in 2020 there have been 1,260 shootings and 256 homicides with blacks being the primary victims. That comes to one shooting victim every three hours and one homicide victim every 15 hours.

■ Three people in Chicago have been killed by police.

If one is truly concerned about black deaths, shootings by police should figure way down on one's list—which is not to excuse bad behavior by some police officers.

As more of our political elite joins the mobs in the streets to conflate the death of George Floyd with a general indictment of America as a racist and evil nation, black Americans, more than anyone, will suffer.

Former President George W. Bush has now weighed in to falsely accuse our nation of "systemic racism."

President Bush was born to a life of privilege. Yet he fell victim to alcoholism and turned to faith and religion to take back responsibility and control of his life.

Yet he has insufficient respect for black Americans, most of whom are born into circumstances far more daunting than anything he has ever known, to grant them the privilege of truth and personal responsibility that have served him so well.

It is simply delusional to suggest that there has been hardly any change in the gaps in income and wealth between blacks and the rest of the nation over the more than half-century since the passage of the Civil Rights Act because of "systemic racism."

If there is a racism that accounts for these persistent disparities, it is the racism of big-government liberals. Now we see some Republicans, many business leaders and even some black conservative leaders signing on to this.

It is a racism that says black Americans cannot adhere to the same eternal truths, to the same law, as everyone else and take personal responsibility for their lives.

Let's recall the observation attributed to George Orwell that says, "In a time of deceit telling the truth is a revolutionary act." All Americans today sorely need to hear the truth amidst the deceit that is now rampant.

Why do racial disparities persist in America today?

Listen to Dr. James Heckman, professor of economics and director of the Center for the Economics of Human Development at the University of Chicago, and winner of the Nobel Prize in economics.

In a recent interview, Heckman was asked, "What do you think are the main barriers to income or social mobility?"

His answer: "The main barriers to developing effective policies for income and social mobility is fear of honest engagement in the changes in the American family and the consequences it has wrought. It is politically incorrect to express the truth and go to the source of problems. Public discourse, such as it is, cannot speak honestly about matters of culture, race, and gender. Powerful censorship is at play across the entire society . . . The family is the source of life and growth. Families build values, encourage (or discourage) their children in school and out. Families—far more than schools—create or inhibit life opportunities."

In 1960, a few years before passage of the Civil Rights Act, 61% of blacks over 18 were married. By 2010, 31% were.

In 2015, per Pew Research, 54% of black children compared with 19% of white children were living in a single-parent home.

If black Americans are victims of anything, it is that they live in a country that has become a wasteland of moral relativism.

What government can do is advance policies to encourage the right behaviors. Allow parental choice in education; advance ownership by replacing the payroll tax with personal retirement accounts; implement housing and health care policy that relies on freedom and choice. And purge ethnicity from existing and future law.

Don't tell me I am indifferent to George Floyd's death. Poor police behavior must be punished. A good start is to diminish the influence of police unions.

But the only systemic racism that poisons and divides our country is the insistence of the powerful to see everyone through the lens of race, placing one's race ahead of one's humanity.

The result is the isolation and separation of the "black community" that they claim to care so much about from the community of the nation and the entire community of God.

It can happen in a moment of time. One ill-advised tweet. One poorly worded post. One foolish act in public. And that's it. You are branded. You are marked. You are guilty. For life.

Whatever good you've done in the past is forgotten, canceled. However deep and sincere your apology, it will never be enough. You must carry the shame for the rest of your days. Away with you!

Ben Howe, author of *The Immoral Majority*, recounts with horror how he helped spread the video posted by a 37-year-old man named Adam Smith. Smith thought he was doing a good thing by berating a Chick-fil-A worker about her allegedly hateful company, and he proudly posted the video of the encounter.

Howe writes, "I didn't spearhead the charge, but I was one member of a growing Twitter mob. The hunt began immediately. By the next day, Smith's video long deleted, Internet sleuths had located his LinkedIn profile and, in short order, his place of work."

Soon enough, he was fired from his job, and despite posting a public apology to the Chick-fil-A worker, named Rachel, he was fired from other jobs after that once news of his connection to the initial video surfaced.

There is no forgiveness and no redemption in the cancel culture. One wrong move, and you are disqualified forever.

According to Howe, "Smith said this pattern repeated itself in the years that followed, and his family eventually had to resort to food stamps to survive without his income. He says he became suicidal, contemplating driving off a cliff so his wife and children could collect on his insurance policy, but he couldn't bring himself to do it. His life had been completely and seemingly irreversibly destroyed."

This is what today's cancel culture does.

Just ask Drew Brees, longtime quarterback of the New Orleans Saints and one of the most popular players in the NFL. And, to my knowledge, a man never before accused of being racist.

But on Wednesday, all hell broke loose against him when he said that he "will never agree with anybody disrespecting the flag of the United States of America or our country."

He was referring to the practice of some NFL players to kneel down during the national anthem as a sign of protest, and he was expressing his disagreement with it.

Was the statement ill-timed in light of the killing of George Floyd?

Would it have been better not to say something like this at all right now?

Even when pressed for his opinion about players kneeling in protest, could he have said, "Now is not the time to ask that question. I want to focus on the pain and frustration experienced by the black community across America."

Yes, I'm sure he could have held his peace or expressed himself differently. And he recognizes that as well.

So, on Thursday, he issued a lengthy, heartfelt apology, speaking with real humility. Then, some hours later, he issued a second apology.

But that will not be enough for many. They will want Brees's head on a platter, so to say. His career must be over. Away with the man!

Some have called for Brees to be fired, despite his extraordinary career spanning almost two decades. Others have wondered if he will be forced to retire ahead of schedule. And plenty of others will want him to wear this reproach for the rest of his life. Let the names of Brees live on in infamy!

Actually, if you watch the video where he was asked how he felt about players protesting during the anthem, he explained what the anthem meant to him. When he hears the anthem, he said, he thinks of his two grandfathers. Both of them fought in World War II and risked their lives to protect our freedoms and to try to make America and the world a better place. The thought of this, during the anthem, sometimes moves him to tears.

So, for him, when we stand for the anthem, we are pledging our unity together, and that is how we can fix the real problems that still exist in our country.

That was it. That was his great crime. And forever, in the eyes of some, his legacy will be tarnished.

Thankfully, not everyone feels this way.

Joe Horn, himself a black American, said, "People should not be throwing Drew Brees under the bus, and they definitely need to pump the brakes on labeling him a racist. I know Drew Brees. Drew has done a lot to help black families and the black community in New Orleans. If Drew Brees didn't love black families and low-income families he wouldn't have helped the way he has over the years. People that are criticizing him like LeBron James and other celebrities don't know him. They need to check his resume."

"I love my race," Horn said. "And I love New Orleans to death. But I know Drew Brees. And Drew is a good person. And until you have walked beside him and gotten to know him, his wife and family, you definitely have to give him a pass on this one and allow Drew a chance to think about what he said and come back and make this right. And I know he will."

Sure enough, Brees did make things right, loudly and clearly. But will the cancel culture even care? For many, the answer is no. Redemption, for them, is a non-existent word.

Tony Dungy, the greatly loved former coach and now NFL TV commentator, said this: "It may have been not exactly the way he wanted to express it, but he can't be afraid to say that, and we can't be afraid to say, 'OK Drew, I don't agree with you, but let's talk about this, and let's sit down and talk about it.'"

Dungy, who is also black, continued, "We can't just say anytime something happens that we don't agree with, 'Hey, I'm done with that and I'm done with this person'. . ."

Precisely so.

But that is what we are doing to each other, with almost fanatical zeal. And where will it lead?

It will lead to self-destruction. The cancel culture will ultimately cancel itself out, as the judge and jury quickly become the guilty party, and in a moment of time at that. The cancel culture will reap what it sows.

What, then, will it be?

Will you sow understanding, mercy, redemption, and forgiveness?

Or will you sow ruthlessness?

Be careful how you choose today. You will reap the results tomorrow.

In recent days, a number of commentators have compared the year 2020 with 1968. But we have not discussed the larger cultural shift that took place as a result of the counterculture revolution of the '60s.

In short, what was extreme and fringe in that generation became mainstream in the next generation.

Put another way, radicals like Bill Ayers of the Weathermen (who bombed buildings in their anti-war protests) became university professors and even mentors of a president (meaning, Barack Obama). Who saw this coming?

Do you think that radical, anti-family feminists in groups like W.I.T.C.H. imagined a world where legalized abortion would snuff out 60 million lives in the womb?

(W.I.T.C.H. stood for the Women's International Terrorist Conspiracy from Hell—I kid you not—and was founded in 1969.)

Do you think that the 1969 Stonewall Inn rioters, hurling bricks at police and their cars and chanting "Gay Power" and "We Want Freedom Now" envisioned the day when the Supreme Court would change the very meaning of marriage?

In 2000, I wrote a mini-book called The Jesus Manifesto. Looking back at some of the opening lines, it sounds almost quaint today. "The last genera-

tion's counterculture of rebellion has become this generation's establishment of revulsion, and what was unthinkable thirty years ago—daytime talk shows celebrating adultery and incest; homosexual love scenes on major network TV; eleven year-old multiple murderers; massacres in our schools and houses of worship—is a matter of course today. We need a revolution!"

Of course, the "revolution" of which I spoke was a gospel-based, moral and cultural revolution, changing hearts and lives and thereby changing the society. But if that was true in the year 2000, it is much truer in the year 2020, when we stand on the precipice of an even more dangerous cultural shift.

- I'm talking about the rise of mobocracy where the most radical elements of society forcefully impose their will on everyone else.

- I'm talking about the "safe space" culture of the college campuses (with enforced speech codes—even thought codes—and severe penalties for every violation) becoming the national norm.

- I'm talking about an even more extreme shift to the left, but this time, under mob patrol.

- I'm talking about the current culture of *The New York Times*, where the publishing of a contrary opinion piece leads to outrage and overhaul in the editorial department, becoming the national norm. (So much for differing opinions!)

As expressed by Alexandra DeSanctis on the *National Review*, "The result is ideological servitude, a society in which a culturally powerful, tyrannical minority owns the voice of every person willing to go along."

And woe be to you if do you not agree to go along.

Of course, many of us have been warning about this for years.

(When it comes to gay activism, I started warning 15 years ago that those who came out of the closet wanted to put us—meaning, Bible-based conservatives—in the closet.)

But now, with the tragic death of George Floyd, the radical activists have seized their moment.

- You must kneel, or else!

- You must embrace our agenda, or you will be trampled underfoot!

- You must bow down, or we will force you to bow!

- If you don't shout "Black Lives Matter" loudly enough or demonstrate sufficient guilt (in particular, for having white skin), you will lose your job. Or your credibility. Or your peace.

One pastor sent me screen shots of the death threats he has received for taking issue with "queer" aspects of the BLM platform. Not today! The mob is coming your way. (This pastor's home address was revealed as well.)

Synagogues vandalized during the riots in Los Angeles have discovered that some of the rioters are also antisemites (why no public outcry?). As a *Times of Israel* headline announced on June 2, "LA Jews reeling after local institutions looted and burned in Floyd protests. Synagogues, schools and Jewish memorials vandalized with anti-Semitic, anti-Israel slogans, Jewish-owned businesses battered, particularly in Fairfax district." But this is no surprise given that BLM also supports BDS.

And what of BLM goals like this?

- "We disrupt the Western-prescribed nuclear family structure requirement by supporting each other as extended families and villages that collectively care for one another, especially our children, to the degree that mothers, parents, and children are comfortable."

- "We foster a queer-affirming network. When we gather, we do so with the intention of freeing ourselves from the tight grip of heteronormative thinking, or rather, the belief that all in the world are heterosexual (unless s/he or they disclose otherwise)."

Of course, we do abhor police brutality when it occurs.

We do stand in solidarity with victims of injustice.

We do oppose racism.

But we do it our way, not the mob's way.

And we do it based on our values, not those of the radical left.

I recently tweeted: "Rather than bowing the knee to the mobocracy of the far left or the hyper-nationalism of the far right, I say we bow the knee to Jesus, then get His marching orders and obey Him at any cost."

I appeal to you strongly, no I warn you: this is a critical hour in our history.

If we do not push back righteously today, we will have deep regrets tomorrow. And what will we say to our children and grandchildren?

In the famous dictum of Dietrich Bonhoeffer, "The ultimate test of a moral society is the kind of world that it leaves to its children."

What will it be?

Lewis and Aboah, a Fargo City Commission candidate, are Black Lives Matter organizers who helped plan the Fargo Marches for George Floyd protests, an event that remained peaceful through much of Saturday as demonstrators walked to Fargo and West Fargo police stations.

It wasn’t until nighttime that police and protesters clashed and destructive rioting ensued. Aboah and Lewis both condemned the violence, saying the perpetrators were not part of their group.

Leaders from the Utah Black Lives Matter movement are condemning the violence and vandalism at Saturday night’s protest in Salt Lake City.

They said the demonstration was not organized by Black Lives Matter, and does not represent what they stand for. The leaders in Utah have been clear, saying there can be no more violence.

“Tonight I hope that activists either stay home or hold a peaceful protest,” said Lex Scott, a founder of Black Lives Matter Utah.

Scott said the damage and violence seen in protests damages the reputation of the people working hard for actual change.

She said: “We have seen the damage in Salt Lake City. We have heard people blaming us for that damage. We have not seen people care about black lives, as much as they care about damage to buildings.”

Scott said Saturday night there were thousands of people participating, but they have not seen thousands participate in their official movement.

“Destroying property and setting fires cannot be your only activism.”

In demonstrations across the country you will see posters, signs, shirts that say “Black Lives Matter.” Scott said it is more than a rallying cry for justice, it is an organization with official members in chapters across the country. To join, members here in Utah have to agree to not destroy property or incite violence.

“If we catch any members destroying property or inciting violence they will be removed from the chapter and I will testify against them myself,” said Scott.

Scott said they meet with Salt Lake City police every two weeks, and that they have made strides with de-escalation and implicit bias training, as well as using less than lethal weapons.

But Scott said there is still a lot of work to be done.

She said: “I can work with Salt Lake Police for three years, but what about Ogden police? They don’t have the same reforms. That’s why we need a national uniform police reform bill.”

She said Black Lives Matter Utah is working to change that. She asked those that want to make a difference to sign their change.org petition, “We Want A Police Reform Bill Now.” She said they have half of the 100,000 signatures they need to take the bill to D.C.

Local leaders within the Reno Black Lives Matters organization say their message was ‘lost’ after vandals turned their protest into a violent riot last Saturday.

“This is not what the movement is about,” says Dr. Norris DuPree Jr., a local community leader who was at the protest.

He said: “Our message is to make sure African Americans who are being killed across our country are taken seriously. It’s a matter of their lives, not to continue spreading violence.”

Dr. Dupree says he has been working with local law enforcement for several years to bring awareness to minorities and to educate African American youth about the role of police in the Reno community.

He and the group’s demonstrators continue to say several people were not from the Reno area and had different intentions than their original message of peace and justice.

“It’s unfortunate because you got people coming to act violent in a place that isn’t their community,” says Dr. DuPree. “This is our community and when we are able to get our voices heard, that’s when we can find unity with one another.”

The group’s official leaders of the protest chose to not comment on the matter.

However, they do say there are no further planned protests in the Reno area from the local Black Lives Matter group.

Law enforcement family

I grew up in a law enforcement family. My father worked his way up to the rank to Captain at the Ft. Smith (AR) Police Department.

As I kid I remember going with him on Friday to pick up his check and I was in awe of these super heroes he worked around.

They were funny and fun to be around. Men and women of all races all with the same mission, to make the community safer.

My dad sacrificed a lot and so did my late mother. Whether it was the week long surveillance or wiretap or chasing drug runners across the country, he gave it all for my family and worked plenty of extra details to never let our family be without. Some would call that privilege but where I grew up, it was called hard work.

The kids at school thought it was cool what my dad did and while he sometimes asked me if anyone gave me a hard time, they never did. There was a respect among all—even the kids in shop class.

Joined the force

I didn't grow up wanting to be a cop but one fateful night, as a freshman in college, that all changed.

I went on a ride along and my life's journey would never be the same.

After four years of college my dad wanted me at an agency that respected that education so I moved to Tulsa (Okla.) at 21 years old and never looked back.

I didn't know anyone and all I knew was what I saw my dad do, work hard and treat people with respect. I saw a lot of other cops working hard as well and doing all they could to keep the community safe.

Times have changed

After publication, this essay met strong criticism from many readers (and many *Times* colleagues), prompting editors to review the piece and the editing process. Based on that review, we have concluded that the essay fell short of our standards and should not have been published.

The basic arguments advanced by Senator Cotton—however objectionable people may find them—represent a newsworthy part of the current debate.

But given the life-and-death importance of the topic, the senator's influential position and the gravity of the steps he advocates, the essay should have undergone the highest level of scrutiny.

Instead, the editing process was rushed and flawed, and senior editors were not sufficiently involved.

While Senator Cotton and his staff cooperated fully in our editing process, the Op-Ed should have been subject to further substantial revisions—as is frequently the case with such essays—or rejected.

For example, the published piece presents as facts assertions about the role of “cadres of left-wing radicals like antifa”; in fact, those allegations have not been substantiated and have been widely questioned.

Editors should have sought further corroboration of those assertions, or removed them from the piece.

The assertion that police officers “bore the brunt” of the violence is an overstatement that should have been challenged.

The essay also includes a reference to a “constitutional duty” that was intended as a paraphrase; it should not have been rendered as a quotation.

Beyond those factual questions, the tone of the essay in places is needlessly harsh and falls short of the thoughtful approach that advances useful debate.

Editors should have offered suggestions to address those problems.

The headline—which was written by The Times, not Senator Cotton—was incendiary and should not have been used.

Finally, we failed to offer appropriate additional context—either in the text or the presentation—that could have helped readers place Senator Cotton's views within a larger framework of debate.

This week, rioters have plunged many American cities into anarchy, recalling the widespread violence of the 1960s.

New York City suffered the worst of the riots Monday night, as Mayor Bill de Blasio stood by while Midtown Manhattan descended into lawlessness. Bands of looters roved the streets, smashing and emptying hundreds of businesses. Some even drove exotic cars; the riots were carnivals for the thrill-seeking rich as well as other criminal elements.

Outnumbered police officers, encumbered by feckless politicians, bore the brunt of the violence.

In New York State, rioters ran over officers with cars on at least three occasions. In Las Vegas, an officer is in "grave" condition after being shot in the head by a rioter.

In St. Louis, four police officers were shot as they attempted to disperse a mob throwing bricks and dumping gasoline; in a separate incident, a 77-year-old retired police captain was shot to death as he tried to stop looters from ransacking a pawnshop. This is "somebody's granddaddy," a bystander screamed at the scene.

Some elites have excused this orgy of violence in the spirit of radical chic, calling it an understandable response to the wrongful death of George Floyd. Those excuses are built on a revolting moral equivalence of rioters and looters to peaceful, law-abiding protesters. A majority who seek to protest peacefully shouldn't be confused with bands of miscreants.

But the rioting has nothing to do with George Floyd, whose bereaved relatives have condemned violence.

On the contrary, nihilist criminals are simply out for loot and the thrill of destruction, with cadres of left-wing radicals like antifa infiltrating protest marches to exploit Floyd's death for their own anarchic purposes.

These rioters, if not subdued, not only will destroy the livelihoods of law-abiding citizens but will also take more innocent lives. Many poor communities that still bear scars from past upheavals will be set back still further.

One thing above all else will restore order to our streets: an overwhelming show of force to disperse, detain and ultimately deter lawbreakers. But local law enforcement in some cities desperately needs backup, while delusional politicians in other cities refuse to do what's necessary to uphold the rule of law.

The pace of looting and disorder may fluctuate from night to night, but it's past time to support local law enforcement with federal authority. Some governors have mobilized the National Guard, yet others refuse, and in some cases the rioters still outnumber the police and Guard combined.

In these circumstances, the Insurrection Act authorizes the president to employ the military "or any other means" in "cases of insurrection, or obstruction to the laws."

This venerable law, nearly as old as our republic itself, doesn't amount to "martial law" or the end of democracy, as some excitable critics, ignorant of both the law and our history, have comically suggested.

In fact, the federal government has a constitutional duty to the states to "protect each of them from domestic violence."

Throughout our history, presidents have exercised this authority on dozens of occasions to protect law-abiding citizens from disorder.

Nor does it violate the Posse Comitatus Act, which constrains the military's role in law enforcement but expressly excepts statutes such as the Insurrection Act.

For instance, during the 1950s and 1960s, Presidents Dwight Eisenhower, John Kennedy and Lyndon Johnson called out the military to disperse mobs that prevented school desegregation or threatened innocent lives and property.

This happened in my own state. Gov. Orval Faubus, a racist Democrat, mobilized our National Guard in 1957 to obstruct desegregation at Little Rock Central High School.

President Eisenhower federalized the Guard and called in the 101st Airborne in response. The failure to do so, he said, "would be tantamount to acquiescence in anarchy."

More recently, President George H.W. Bush ordered the Army's Seventh Infantry and 1,500 Marines to protect Los Angeles during race riots in 1992. He acknowledged his disgust at Rodney King's treatment—"what I saw made me sick"—but he knew deadly rioting would only multiply the victims, of all races and from all walks of life.

Not surprisingly, public opinion is on the side of law enforcement and law and order, not insurrectionists.

According to a recent poll, 58 percent of registered voters, including nearly half of Democrats and 37 percent of African-Americans, would support cities' calling in the military to "address protests and demonstrations" that are in "response to the death of George Floyd."

That opinion may not appear often in chic salons, but widespread support for it is fact nonetheless.

The American people aren't blind to injustices in our society, but they know that the most basic responsibility of government is to maintain public order and safety.

In normal times, local law enforcement can uphold public order. But in rare moments, like ours today, more is needed, even if many politicians prefer to wring their hands while the country burns.

In the meantime, in February, Fauci, parroting the WHO's Tedros Adhanom, was telling us that the virus was no big deal and that there was no reason for people to start wearing masks.

As we now know, Fauci prostrates himself at the feet of Adhanom, who, in turn, does the same at the feet of Xi Jinping.

■ Planned Parenthood

■ Many killed in Chicago

Just for the record, over the weekend, 10 black people were killed in Chicago. But their deaths were generally ignored because they were murdered by other blacks and not by Officer Derek Chauvin, who had an alibi because he was busy elsewhere murdering someone else.

■ Police sitting back

You would think by now that city leaders would know what a stupid tactic it is to sit back and let riots simply play out for fear that a pushback by the cops would merely incite further violence. It's fortunate that the folks at the Pentagon don't adopt that practice at time of war.

■ Broken window syndrome

What made New York the safest city in America during Rudy Giuliani's tenure as mayor was that he adopted what he called the broken window syndrome.

He realized that if one building on a block had a broken window and nobody bothered to repair it, soon there would be a lot more broken windows. He knew that nihilism was the predictable next step when people stopped caring enough to fix a window or report a crime or began to lose respect for authority.

June 7, 2020

Mr. President,

In recent months we have been witnessing the formation of two opposing sides that I would call Biblical: the children of light and the children of darkness. The children of light constitute the most conspicuous part of humanity, while the children of darkness represent an absolute minority.

And yet the former are the object of a sort of discrimination which places them in a situation of moral inferiority with respect to their adversaries, who often hold strategic positions in government, in politics, in the economy and in the media.

In an apparently inexplicable way, the good are held hostage by the wicked and by those who help them either out of self-interest or fearfulness.

These two sides, which have a Biblical nature, follow the clear separation between the offspring of the Woman and the offspring of the Serpent.

On the one hand there are those who, although they have a thousand defects and weaknesses, are motivated by the desire to do good, to be honest, to raise a family, to engage in work, to give prosperity to their homeland, to help the needy, and, in obedience to the Law of God, to merit the Kingdom of Heaven.

On the other hand, there are those who serve themselves, who do not hold any moral principles, who want to demolish the family and the nation, exploit workers to make themselves unduly wealthy, foment internal divisions and wars, and accumulate power and money: for them the fallacious illusion of temporal well-being will one day—if they do not repent—yield to the terrible fate that awaits them, far from God, in eternal damnation.

In society, Mr. President, these two opposing realities co-exist as eternal enemies, just as God and Satan are eternal enemies. And it appears that the children of darkness—whom we may easily identify with the deep state which you wisely oppose and which is fiercely waging war against you in these days—have decided to show their cards, so to speak, by now revealing their plans.

They seem to be so certain of already having everything under control that they have laid aside that circumspection that until now had at least partially concealed their true intentions.

The investigations already under way will reveal the true responsibility of those who managed the Covid emergency not only in the area of health care but also in politics, the economy, and the media.

We will probably find that in this colossal operation of social engineering there are people who have decided the fate of humanity, arrogating to themselves the right to act against the will of citizens and their representatives in the governments of nations.

We will also discover that the riots in these days were provoked by those who, seeing that the virus is inevitably fading and that the social alarm of the pandemic is waning, necessarily have had to provoke civil disturbances, because they would be followed by repression which, although legitimate, could be condemned as an unjustified aggression against the population.

The same thing is also happening in Europe, in perfect synchrony. It is quite clear that the use of street protests is instrumental to the purposes of those who would like to see someone elected in the upcoming presidential elections who embodies the goals of the deep state and who expresses those goals faithfully and with conviction.

It will not be surprising if, in a few months, we learn once again that hidden behind these acts of vandalism and violence there are those who hope to profit from the dissolution of the social order so as to build a world without freedom: *Solve et Coagula*, as the Masonic adage teaches.

Although it may seem disconcerting, the opposing alignments I have described are also found in religious circles.

There are faithful Shepherds who care for the flock of Christ, but there are also mercenary infidels who seek to scatter the flock and hand the sheep over to be devoured by ravenous wolves.

It is not surprising that these mercenaries are allies of the children of darkness and hate the children of light: just as there is a deep state, there is also a deep church that betrays its duties and forswears its proper commitments before God.

Thus the Invisible Enemy, whom good rulers fight against in public affairs, is also fought against by good shepherds in the ecclesiastical sphere. It is a spiritual battle, which I spoke about in my recent Appeal which was published on May 8.

For the first time, the United States has in you a President who courageously defends the right to life, who is not ashamed to denounce the persecution of Christians throughout the world, who speaks of Jesus Christ and the right of citizens to freedom of worship.

Your participation in the March for Life, and more recently your proclamation of the month of April as National Child Abuse Prevention Month, are actions that confirm which side you wish to fight on.

And I dare to believe that both of us are on the same side in this battle, albeit with different weapons.

For this reason, I believe that the attack to which you were subjected after your visit to the National Shrine of Saint John Paul II is part of the orchestrated media narrative which seeks not to fight racism and bring social order, but to aggravate dispositions; not to bring justice, but to legitimize violence and crime; not to serve the truth, but to favor one political faction.

And it is disconcerting that there are Bishops—such as those whom I recently denounced—who, by their words, prove that they are aligned on the opposing side.

They are subservient to the deep state, to globalism, to aligned thought, to the New World Order which they invoke ever more frequently in the name of a universal brotherhood which has nothing Christian about it, but which evokes the Masonic ideals of those who want to dominate the world by driving God out of the courts, out of schools, out of families, and perhaps even out of churches.

The American people are mature and have now understood how much the mainstream media does not want to spread the truth but seeks to silence and distort it, spreading the lie that is useful for the purposes of their masters.

However, it is important that the good—who are the majority—wake up from their sluggishness and do not accept being deceived by a minority of dishonest people with unavowable purposes.

It is necessary that the good, the children of light, come together and make their voices heard.

What more effective way is there to do this, Mr. President, than by prayer, asking the Lord to protect you, the United States, and all of humanity from this enormous attack of the Enemy?

Before the power of prayer, the deceptions of the children of darkness will collapse, their plots will be revealed, their betrayal will be shown, their frightening power will end in nothing, brought to light and exposed for what it is: an infernal deception.

Mr. President, my prayer is constantly turned to the beloved American nation, where I had the privilege and honor of being sent by Pope Benedict XVI as Apostolic Nuncio.

In this dramatic and decisive hour for all of humanity, I am praying for you and also for all those who are at your side in the government of the United States.

Let the wicked forsake his way, and the unrighteous man his thoughts; let him return to the LORD, and He will have mercy on him; and to our God, for He will abundantly pardon. ‘For My thoughts are not your thoughts, nor are your ways My ways,’ says the LORD. For as the heavens are higher than the earth, so are My ways higher than your ways, and My thoughts than your thoughts. For as the rain comes down, and the snow from heaven, and do not return there, but water the earth, and make it bring forth and bud, that it may give seed to the sower and bread to the eater, so shall My word be that goes forth from My mouth; it shall not return to Me void, but it shall accomplish what I please, and it shall prosper in the thing for which I sent it.”
