Question: What book is the opposite of the left?

Answer: the Torah.

The Torah is the Hebrew name of the first five books of the Bible, the “Five Books of Moses.” The Torah is the foundation of the rest of the Bible and the rock on which both Judaism and Christianity stand. No Torah, no Judaism. No Torah, no Christianity. No Torah, no God, no divine creation, no Exodus, no Ten Commandments, no “love your neighbor as yourself,” no Judeo-Christian values, no Western civilization and no America.

As I am about to finish the third volume of my five-volume commentary on the Torah (“The Rational Bible”), I can say with some authority that the Torah is the antithesis of left-wing ideas and values. It is not the antithesis of lib-

eral ideas and values; it is the antithesis of left-wing values and ideas. A serious and committed Jew or Christian can be a liberal or a conservative; he or she cannot be a leftist. Left-wing Jews and Christians use Judaism and Christianity as covers for their real values—left-wing values.

Following are examples of basic laws and values in the Torah that are the opposite of what the left advocates.

■ *No. 1: "Do not show favoritism to a poor person in passing judgment" (Exodus 23:3). "Do not pervert justice. Do not show partiality to the poor or favoritism to the great, but judge your neighbor fairly" (Leviticus 19:15).*

The left advocates judging the poor differently. A poor man who commits almost any crime, including a violent crime, is not to be held to the same legal or moral standard as other people. As reported last week in the City Journal:

"In October, the Seattle City Council floated legislation to provide an exemption from prosecution for misdemeanor crimes for any citizen who suffers from poverty, homelessness, addiction, or mental illness. Under the proposed ordinance, courts would have to dismiss all so-called 'crimes of poverty'—which, according to the city's former public-safety advisor, would cover more than 90 percent of all misdemeanor cases citywide."

Since Karl Marx, the left has not divided the world between right and wrong, as the Torah, Judaism and Christianity do, but between rich and poor.

■ *No. 2: "Honor your father and mother" (the fifth of the Ten Commandments—Exodus 20:12 and Deuteronomy 5:16).*

Parental authority (as much as divine authority) is probably the greatest single obstacle to the left attaining control over a society. Therefore, the left, like all totalitarian movements and like all cults, has always sought to undermine parental authority. That is precisely what has been taking place in America over the past few generations. In every case, the diminution of parents' authority over their children is portrayed as reasonable and even morally necessary, but the end is clear: Allow left-wing laws and institutions to direct your children.

Your 9-year-old daughter says she is a boy? Your 9-year-old son says he is a girl? Neither you nor any therapist has a right to tell him or her otherwise. Your minor-age daughter says she is a boy and wants to start hormone therapy and even have her breasts surgically removed? You are in no position to stop her.

Parents who allow their young children to take walks by themselves are increasingly reported to child protective services. The authorities—not you, the parents—will determine at what age your children can take walks unaccompanied by an adult.

Even school breakfasts undermine parents' authority. One of the most fundamental things parents do for their children is feed them. But increasingly, progressive cities provide not only lunch but also breakfast for your child. The message is clear: We, not your parent(s), will take care of your needs.

■ *No. 3: "Male and female He created them" (Genesis 5:2).*

The distinction among human beings between male and female is built into creation. It is the only human distinction other than good and evil that matters. In the Torah, there is no built-in ethnic or racial distinction among human beings; God couldn't care less about race. But the male-female distinction is a fundamental part of the divine order.

■ *No. 4: Race means nothing.*

The creation of one human being, Adam, whose race is unknown, made it impossible to argue that race matters. This is another major conflict between the left and the Torah, given how important race is to the left. Adam, and therefore every human being, is created in the image of God—and, of course, God has no color.

■ *No. 5: Distinctions.*

Distinctions lie at the very heart of creation. The left's war on the Judeo-Christian religions is rooted in its war against distinctions.

Male-Female: The left seeks to destroy this fundamental human distinction. The issue is not trans rights. If a person of majority age seeks to change his or her sex, the Torah is silent on that issue. The issue is the blurring of the male-female distinction—forcing people to lie about reality and say, "Men give birth" and, "Men menstruate" or having men who identify as men, look like men and have a man's name publicly wear women's clothing, as Harry Styles did on the cover of Vogue.

Man-God: Karl Marx wrote, "Man is God." The left has always sought to displace God with man. The desire to be a god—meaning the one who, rather than God, determines good and evil—has tempted human beings since Adam and Eve in the Garden of Eden.

Good-Evil: On the left, good and evil are subjective. In the Torah, they have an objective reality. Moreover, the left's moral compass does not divide human beings and their actions between good and evil but between rich and poor, white and nonwhite, strong and weak.

God-Nature: The opening verse of the Torah ushered in one of the most radical innovations in history: God created nature; God is not part of nature. On the left, however, nature is God.

Human-Animal: On the left, human beings are just another animal. In the Torah, only man is created in God's image.

The left knows the Bible and the Judeo-Christian values that emanate from it are its enemy. The rest of us should, too.

China is massively expanding its weather-control project, and is aiming to be able to cover half the country in artificial rain and snow by 2025, the government said Tuesday [Dec. 1].

The practice of “cloud seeding” was discovered in the US in 1946 by a chemist working for General Electric. China launched its own similar program in the 1960s.

Dozens of other countries—including the US—also have such programs, but Beijing has the world’s largest, employing around 35,000 people, The Guardian reported.

In a statement, China’s State Council said that the country’s cloud seeding project will expand fivefold to cover an area of 2.1 million square miles and be completed by 2025. (China encompasses 3.7 million square miles, meaning the project could cover 56% of the country’s surface area.)

The project will be at a “worldwide advanced level” by 2035, the State Council said, and will help alleviate “disasters such as drought and hail” and facilitate emergency responses “to forest or grassland fires.”

Generating artificial rain and snow is fairly simple in principle. Spraying chemicals like silver iodide or liquid nitrogen into clouds can make water droplets condense, and fall as rain or snow.

China launched a localized cloud seeding project in Beijing shortly before the 2008 Olympics, which it said successfully forced anticipated rains to fall before the event started.

In June 2016, China allocated \$30 million to its cloud seeding project, and started firing bullets filled with salt and minerals into the sky.

A year later, China spent \$168 million on a huge supply of equipment to facilitate the project, including four aircraft and “897 rocket launchers,” The Guardian said.

As Business Insider previously reported, China’s Ministry of Finance wanted to use cloud seeding to create at least 60 billion cubic meters of additional rain every year by 2020.

In January 2019, state media reported that cloud seeding tactics in the western region of Xinjiang had prevented crops from 70% of hail damage.

I met economist and professor Walter Williams when I interviewed him while hosting a local TV show in Cleveland. We discussed a number of topics but focused on race-based preferences, aka affirmative action. Williams adamantly opposed it, still an unpopular position to take, but especially back then and especially for a Black person. He calmly explained how affirmative action causes a mismatch between a student and his or her ability to succeed on a campus more competitive than would have been the case but for the race-based preferential admission. Without racial preferences, I said, schools like Harvard might have few or no Blacks. To this Williams said, "So?"

For decades, Ebony magazine, the Black monthly magazine, sat prominently on the coffee tables in Black households across America. No longer owned by the original family, it has lost its clout. But for years, Ebony featured the "100 Most Influential Black Americans," until the large number of "influential" Black Americans caused them to rename the feature "The 100+ Most Influential Black Americans."

And every year, despite the expanded number of Black influentials, Ebony omitted Supreme Court Justice Clarence Thomas, economist Thomas Sowell and Williams. Never mind that Williams, to the best of my knowledge, still holds the distinction as the only Black economics professor to chair an economics department of a non-Black college or university. But he could not make the cut in Ebony.

- In 2001, I wrote: "Someday, many of their critics will apologize. Who am I talking about? Two economists, who happen to be Black, Thomas Sowell and Walter Williams. For over 30 years, Thomas Sowell, currently with the Hoover Institution, and Walter Williams, chairman of the economics department at

George Mason University, led the charge against the 'victicrat' mindset. Through decades of weekly columns, books, speeches and lectures before often-hostile crowds, they long argued that racism cannot be blamed for poverty, crime, illegitimacy, and under-performing schools . . . Sowell and Williams urge Blacks to reject welfare in favor of self-help—breaking the monopoly of public education, privatization of Social Security, and the adherence to responsible moral, personal, and sexual behavior. So who's the Uncle Tom? Those proposing the same old 'solutions,' or those, like Sowell and Williams, recommending real change?"

■ In 2017, I wrote: "How does Ebony justify excluding economist and writer Walter Williams, former chairman of the economics department of George Mason University, where he still teaches? Raised by a single mother, he lived in Philadelphia's Richard Allen housing projects. He served as a private in the Army before earning a bachelor's degree at a state university, followed by a master's and a Ph.D. in economics at UCLA. Williams has written a dozen books on economics and race, including the inspirational 'Up From the Projects: An Autobiography,' and was recently the subject of a documentary about his life. The exclusion of people like Clarence Thomas, Thomas Sowell and Walter Williams explains why there's no serious discussion in the Black community about government dependency; school choice; the damage done by high taxes, excessive regulation and laws like minimum wage; and why Blacks should rethink their allegiance to the Democratic Party."

■ In 2019, I wrote: "I have known Sowell and Williams for nearly 30 years. Their presence loomed large this weekend in Washington, D.C. For years, they were lonely voices questioning Blacks' devotion to the Democratic Party. They have long argued that the welfare state has destabilized families, encouraging women 'to marry the government' and men to abandon their financial and moral responsibilities. They have long argued against the job-destroying impact of the minimum wage. They have long argued that one's fate is determined not by racism but by one's willingness to invest in oneself through education, hard work and sacrifice. Turning Point's Black Leadership Summit shows that Sowell's and Williams' books, columns, television appearances and speeches have spawned a generation of hopeful young Black men and women who believe in themselves. These bright, energetic young people get it."

About his best friend of 50 years, fellow economist Thomas Sowell recently wrote the following.

■ "As an economist, Walter Williams never got the credit he deserved. His book 'Race and Economics' is a must-read introduction to the subject. Amazon has it ranked 5th in sales among civil rights books, 9 years after it was published . . . The other side of Walter came out in relation to his wife, Connie. She helped put him through graduate school—and after he received his Ph.D., she never had to work again, not even to fix his breakfast . . . We may not see his like again. And that is our loss."

Americans cherish religious freedom. And the covid-19 crisis has reminded people of faith, especially how much they value this critical First Amendment right. For me, a Christian, the past eight months of lockdowns have underscored the importance of in-person worship or, rather, the importance of fellowship in nurturing one's spiritual life.

As David Mathis, a pastor and executive editor of Desiring God, says, "Worshipping Jesus together may be the single most important thing we do. It plays an indispensable role in rekindling our spiritual fire and keeping it burning. Corporate worship brings together God's word, prayer, and fellowship, and so makes for the greatest of God's ongoing grace in the Christian life."

Pastor Mathis and I aren't the only ones who feel this way about religious freedom. According to the findings of the Becket Fund's second annual Religious Freedom Index, Americans, in general, believe religious faith is an

inherent, key part of public life and that faith or religion is an important factor for navigating the coronavirus pandemic.

Sixty percent of Americans, for example, agree religion isn't simply a week-end diversion recreational but a necessary, fundamental part of a person's identity that should be protected. Indeed, a majority of Americans believe safely reopening places of worship should be treated with the same urgency as safely reopening businesses.

Americans have rightly been frustrated with leaders who, during parts of the pandemic, haven't given the same deference to places of worship they give to businesses. Catholic political commentator Timothy P. Carney perhaps captured it best when in April he pointed out the unfair way churches and places of worship were treated compared to retail stores.

"This past weekend, amid the broad coronavirus shutdown, you could buy your Mad Dog 20/20 at your liquor store. You could pick up your shiplap and wood stain at Home Depot. Dozens of people could congregate under one roof, as long as it was a Big Box store," he said. "But you couldn't go to church for Easter service."

When churches across the country were finally allowed to reopen at partial capacity with robust social-distancing and sanitizing measures in place, Americans were overjoyed to worship together again in person instead of via YouTube, Zoom, or Facebook Live.

After Republican Texas Gov. Greg Abbott at the end of April issued guidelines for Lone Star State churches to begin reopening, Pastor Randy Phillips prepared to return to the pulpit. This time, however, his congregation listened to his sermon from the church's 1,500-seat outdoor amphitheater, where attendance was limited to 350 people.

"You mean so much to me," Phillips told his congregation. "I will never take it for granted again—the beautiful fellowship we have together as believers," he said. Congregant Molly Lintz shared similar feelings. "It's nice to be back with the community," she said. "You just don't get the same feeling over Zoom."

An overwhelming majority of Americans, moreover, believe religion is an important, stabilizing influence on society during times of social upheaval. When churches and after-school religious programming is forced to close, unrest is amplified as young adults have fewer outlets through which to productively channel their energy.

Americans made it loud and clear that religion isn't a tertiary sphere of life where they occasionally dip their feet. No, religion is a central part of American life, and voters will support candidates who defend Americans' First Amendment right to religious freedom.

Christians, specifically, know that "where two or three are gathered," as the book of Matthew says, God is in the midst of them. This is a comforting truth to rest in during lockdown when one is isolated from the church family. But, the importance and gift of in-person fellowship, and worship, for people of faith remains critically important.

Americans need and deserve leaders who will be as quick to defend believers' right to worship publicly as they are to defend the right of business owners to operate and make payroll. Leaders would do well to take notice of this now and in future elections.

In the chaotic weeks since the presidential election in November, the news from conservative media has been dominated with charges of suspicious late-night deliveries of mail-in ballots and statistically impossible vote surges for the Biden-Harris ticket. While those are serious charges that require investigation, they are just some of the many ways we have learned how our electoral process is wide open for manipulation. Another way is the presence of non-citizens in the United States finding their way onto voting rolls, and it is just as great a threat as what has been alleged by the Trump campaign.

The American people have been warned about this for years. Illegal immigration metastasizes throughout our country and harms it in innumerable ways. Some of the most obvious symptoms are more competition for jobs, higher crime, and more drain on limited social services resources.

Then there are the less noticeable but equally dangerous other effects, like the harm it does to our electoral process. My organization, the Immigration Reform Law Institute, recently completed an investigation into electoral procedures in North Carolina, and the results are disturbing.

In many states, jurors are selected from lists of driver's license holders and those on voting rolls. We found that in Mecklenburg County, the state's second most populous county which includes metropolitan Charlotte, a total of 51 individuals were removed from the jury pool list because of non-citizenship between October 28, 2019 to July 7, 2020, as confirmed to us by the county's Jury Office. We found similar results in two other large counties, Cumberland and Forsyth.

While a spokesman for the state's judicial branch told us the non-citizens came from the driver's license records, it does not eliminate the possibility that they are coming from voter rolls. Even the potential that they are coming from voter rolls brings the integrity of North Carolina elections into question. What revelations might a more comprehensive, statewide investigation bring, in North Carolina or any other state?

There is unlikely to be a wider investigation into this problem, however, in North Carolina or elsewhere. Why? Because the end result of the problem benefits certain politicians and their parties. While the Democrats are the primary beneficiaries of this, there are plenty of establishment Republicans who passively support it. Why fix something that is serving them so well?

That illegal immigration is tainting the integrity of our elections is not an unintended consequence, but rather it is by design. It is designed to keep money flowing into incumbents' re-election campaigns and to allow them to stay in power.

Politicians have become practiced at selling mass migration to the public. Alexandria Ocasio-Cortez in 2018 was photographed, grief-stricken, at the gates of an immigrant detention facility in Texas which was actually an empty road. Sen. Chuck Schumer once brought out Syrian immigrants as human shields for a press conference and even burst into tears while attacking President Trump's travel ban.

They put on quite a show that probably sways some people to their side, but it obfuscates from the true objective: to use immigration as a near-infinite source of new voters who will reliably vote for establishment politicians who offer them safe haven in America and access to a deep pool of welfare benefits, schools and jobs. American citizens who may suffer from all this are acceptable collateral damage. As a cherry on top, Big Business industries looking for the cheap labor that mass immigration provides will underwrite the campaigns of ambitious politicians if they play ball.

This thinly-veiled voter registration drive is buttressed by a host of other related policy positions. Not coincidentally, anti-borders politicians are also against voter ID requirements at polling places, restrictions on mail-in voting, and any attempt to authenticate voter signatures. Anything that brings more transparency to elections is clearly a sign of racism towards those who don't look like us. It's a devilishly clever scheme: subvert the legitimate electoral process to feather your own political nest, while wrapping yourself in the veneer of a true humanitarian doing it in the name of civil rights for all. Machiavelli couldn't have done it better.

The presidential election of 2020 should go down in history with a giant asterisk for the Third World manner in which the votes were tabulated. It should also be a sign of things to come if we continue to allow the malignant effects of illegal and excessive legal immigration on our country to go untreated.

■ JOHN ASHCROFT, 2000

John Ashcroft absolutely had a Senate seat stolen from him in 2000 when a state judge ordered polls in heavily Democratic St. Louis to remain open for an extra three hours. Republicans didn't even hear about it for another hour. Despite an appellate court striking down the ridiculously lawless order, St. Louis was given an extra 3½ hours to kick out tens of thousands of additional votes. Ashcroft lost the election by 49,000 votes.

■ WASHINGTON STATE, 2004

A week after the 2004 Washington state gubernatorial election, Republican Dino Rossi was up by 3,492 votes against Democrat Christine Gregoire. Then Democratic King county began finding "misplaced" ballots, eventually producing more than 10,000 of them.

Hey, guys! I found another box of ballots under the sink!

So that's another 800 votes for Gregoire.

Notwithstanding the miraculously appearing ballots, Rossi won the recount a few weeks later, but his lead was cut to 42 votes—easily within stealing distance. Democrat Christine Gregoire demanded a hand recount, and that put her ahead by 129 votes, whereupon she was promptly declared the winner.

Washington voters overwhelmingly believed the election had been stolen and wanted a revote. Democrats didn't care. Nothing was ever done about the flagrant vote fraud. Washington now has 100 percent mail-in-ballots and no Republican has ever again won the governorship.

■ AL FRANKEN, 2008

In 2008, Sen. Norm Coleman of Minnesota won his 2008 reelection bid against challenger Al Franken by 725 votes. But for weeks after the election, Democratic precincts kept "discovering" new votes for Franken.

Day after day, votes were added to Franken's column, while votes were taken away from Coleman. Random error would not continually benefit only one side.

On account of Franken's charisma shield, Barack Obama, who was running for president that year, won hundreds of thousands more votes than Franken in the same election, on the same ticket, in the same state that year. But during the "corrections," Franken was winning three times as many votes as Obama.
