In a 1983 speech before the National Association of Evangelicals, President Ronald Reagan labeled the Soviet Union the “evil empire;” perfectly capturing the moral and political danger presented by that communist regime. Reagan properly cautioned Americans not to “ignore the facts of history and the aggressive impulses” of an enemy that was “the focus of evil in the modern world.”

Unfortunately, what was clear to Reagan about the Soviet Union in 1983 appears only as a blur to Joe Biden about China today.

If the Soviet Union were the evil empire, then China is surely the vilest empire. The Soviet Union’s global ambitions for its evil empire were hampered by its own incompetence. China, however, actively spreads its insidious tentacles across the world with a shocking mastery, facilitated by the apparent unwillingness of global leaders, including Biden, to take the threat seriously.

Today’s China presents for the United States and other western powers a far more complex and multi-faceted danger than that posed by the Soviet Union in the second half of the last century. While China’s military build-up, and its well-documented willingness to use that power (especially as it relates to Taiwan) is a real concern, it is but one dimension of the broader threat, and in some ways not the most serious.

Take, for instance, China's push for greater influence in American academic institutions by way of funding educational programs and centers, under the guise of benignly teaching Chinese language and culture. As a white paper published at the Heritage Institute earlier this year suggests, this funding is a Trojan horse for Beijing to expand its influence in American culture more broadly. Strings attached to such financial largesse ensure that recipient universities carefully avoid saying or doing anything that Beijing considers insulting or critical of its policies. This is, of course, when Chinese students themselves are not agents for their government, as the FBI itself had warned.

In the global economy, state-based hacking of U.S. companies operating in China to steal trade secrets and reverse engineer products for theft is common knowledge. However, consumer goods produced from Chinese companies are also routinely—and often literally—weaponized for the communist government and its military.

China made headlines a few years ago when it was discovered it used compromised microchips to infiltrate several major U.S. companies.

Evidence that the covid-19 virus was the byproduct of Chinese military research persists, despite being routinely downplayed by the Biden Administration and other governments and international organizations. As I have written previously, even prior to the arrival last year of the covid virus, it is insane that American companies and other institutions remain willing, and are permitted by our own government, to engage in highly sensitive research that can and will be used by China's military.

Just this month it was revealed that a prenatal genetic screening test sold by a Chinese company was developed in tandem with the Chinese military and used to harvest genetic material for military and social research. If secretly stealing the genetic material of unsuspecting women is not the definition of evil, one might wonder what is.

China's domestic agenda, with its brutal crackdowns on minority groups and on Hong Kong citizens, provides a horrifyingly clear picture for what this truly evil empire would have in store for the rest of the world.

Despite the naivety with which many commentators from both the left and right fawn over China's booming "private" sector, this faux capitalism is simply another weapon for China to use against its global adversaries. The illusion of Chinese markets ready and waiting for foreign investors is merely the bait in the trap. After those investments are made, investors like Disney, Google, and the NBA discover that doing business in China comes with many "conditions." It is no coincidence that the hyper-political NBA is deathly silent on China's human rights abuses.

Unlike the Soviets, who were consumed with immediate expansion of their influence and power, ultimately leading to the collapse of the Soviet Union, China is committed to playing the long game. A crucial part of this plan is undermining America's historic role as the world's moral compass. China does this by compelling our silence through political intimidation or economic ransom, thus giving tacit consent to their evil deeds.

Not only are the Biden Administration and its cohorts in the Congress blissfully ignorant of Reagan's prescient warnings about dealing with evil empires, but they appear to be willing facilitators of China's strategic goals.

Question my sanity, but I’m considering running in this election to recall California’s Democratic Gov. Gavin Newsom. Here’s a big reason why.

No one doubts that bad K-12 public school teachers exist. There is a phenomenon known as the “turkey trot,” in which bad teachers wind up in the worst schools.

Why? There is a connection between bad schools and lack of parental involvement. When you have strong parental involvement, parents pressure their schools to remove such teachers. Because of strong, protective teachers unions, these teachers are rarely fired, merely shuffled from school to school, until they land in one where few parents complain.

And while the vast majority of teachers do not fall into that “bad” category, look at where public school teachers send their *own* school-age children. Nationwide, approximately 10% of kids attend private school. Six percent of Black kids do so. But more than 20% of public school teachers send their own kids to private schools.

A 2004 study by the Fordham Institute found that 44% of Philadelphia public school teachers send their kids to private schools. In Cincinnati and Chicago, 41% and 39% of public school teachers, respectively, put their own school-age children in private school.

In Baltimore, in 2017, there were 13 public high schools where 0% of students could do math at grade level, with another half a dozen Baltimore public high schools where only 1% could do so. So, it is hardly a surprise that Fordham’s study found 35% of Baltimore public school teachers with school-age kids placed them in private school. In San Francisco it was 34%, and New York-Northeastern New Jersey was 33%. In Los Angeles, nearly 25% of public school teachers sent their kids to private school, versus 16% of Angelenos who did so.

For this reason, school choice has never polled higher. A June 2021 RealClear Opinion Research poll found support for school choice at 74% among registered voters. This includes 83% of Republicans, 69% of independents and 70% of Democrats who strongly or somewhat support school choice. In April, 2020, sup-

port for choice was 64%. Tommy Schultz, CEO of the American Federation for Children, said: "Public support for school choice is at an all-time high. And, as the nation recovers from unprecedented, nationwide school closures, a new story is unfolding. Parents are rising up and demanding the freedom to choose the best educational environment for their children . . . Already in 2021, seventeen states have passed legislation to improve, expand, or create new school choice programs."

School choice is not a panacea, especially without strong parental involvement. Studies show that Black kids spend less time doing homework than Hispanic kids, less time on homework than white kids and much less time on homework than Asian American kids. Economist Walter Williams told me, "If you don't have someone in your household to make sure that you do your homework and to insist that you go to bed on time, the school you attend will not make a whole lot of difference."

When I was in elementary and middle school, several classmates were Asian American, most of Chinese or Japanese descent. They all told me the same thing. If they got a B—they rarely got a grade lower than that—their parents told them they did not work hard enough. If they got an A, their parents told them the test was too easy. Their parents did not accept the notion often heard from my Black classmates, that so-and-so is "just not good in math." The parents of my Asian American classmates believed that in academics, as athletic coaches say, "Hard work beats talent when talent doesn't work hard."

School choice benefits children of parents who preach that education and hard work are key to upward mobility. School choice will be of little benefit to the kids of parents who do not.

In some respects, Canada has been a step ahead of America in terms of moral and cultural decline. That means that what happens in Canada today—and I mean what happens in the most negative sense—could well be coming to America tomorrow.

Of course, in other respects, America is far ahead of Canada in terms of serious moral issues. Just consider the difference in gun violence between our nations. Or ask yourself who is the world leader in exporting and providing porn, Canada or America?

Yet, when it comes to government overreach or attacks on fundamental liberties or hostility towards the Church, Canada's descent has been more frightening.

We do well to pay attention to what is taking place to our north.

For example, Canada legalized same-sex "marriage" in 2005, a decade before the Supreme Court's Obergefell decision, without which the states would

have been battling over the issue for years to come. Not surprisingly, Canada was also well ahead of America in terms of prosecuting Christians who opposed gay activism and propaganda.

To give one case in point, already in 2006, a Canadian professor was “fined two weeks pay by a Nova Scotia university for telling a student that homosexuality is an unnatural lifestyle . . . Cape Breton University (CBU) fined veteran history professor David Mullan \$2,100 in response to two human rights complaints filed by a homosexual student who coordinates the campus’ Sexual Diversity Office. The student took umbrage at two letters the professor had written to his former Anglican bishop two years ago.”

Canada has also been ahead of the U.S. in passing national legislation that would punish those who refused to comply with transgender activism, such as choosing not to refer to a male as a female if that person identified as such.

Now, according to Tyler O’Neil on PJ Media, a new bill, Bill C-36, would “enable citizens to bring legal claims against people who engage in ‘hate speech’ online, and if a member or panel of the Canadian Human Rights Tribunal finds the accused guilty, the tribunal can either: order the accused to ‘cease the discriminatory practice’ and take steps to prevent it from happening again; order the accused to pay compensation of up to \$20,000 ‘to any victim personally identified in the communication that constituted the discriminatory practice,’ or order the accused to ‘pay a penalty of not more than \$50,000 to the Receiver General’ if the tribunal ‘considers it appropriate’ considering ‘the nature, circumstances, extent and gravity of the discriminatory practice.’ ”

And what, exactly, would be defined as hate speech, especially if it simply needs to be hateful in the eye of the beholder? O’Neil rightly warns, “Claims about ‘hate speech’ are arguably even more slippery than claims about discrimination, and it seems extremely likely that Canada’s government will use this law to silence dissent from the government’s preferred ideologies—from transgender orthodoxy to covid-19 (the border between the U.S. and Canada is still closed to those filthy Americans).”

Is there any reason that this could not become the law of the land in America too?

Then there is the overt hostility towards churches, to the point of saying publicly, “Burn them all down!”

As I mentioned, for years Christians in Canada have been prosecuted for opposing gay activism, with the noose getting tighter by the year.

In more recent months, pastors who refused to comply with the government’s covid-related overreach have served time in jail, producing more national hostility to these allegedly lawless Christians who are supposedly endangering their fellow-Canadians.

Just last month, as reported by the *Christian Post*, a Canadian pastor was “arrested after his church held an outdoor worship service at an undisclosed location after the local government ordered the church building to be closed.”

Yes, the “congregation was reportedly discovered by a police helicopter” as they met outdoors, meaning that they were *not* violating covid guidelines for indoor meetings. Can you imagine holding an outdoor service to worship Jesus together, only to look up and see a police helicopter overhead? You have been found out! You are guilty! We found you!

The next day, the pastor was arrested. This really happened.

But it gets worse.

As reports have been emerging about unmarked graves being found at residential schools on First Nations reserves (roughly the equivalent of Native American reservations), church buildings are being set on fire, since these schools, which began in the 1800s, were normally church-led.

The discovery of these graves has prompted a national outcry, as if hundreds of children were killed or allowed to die by these schools. And certainly, there should be thorough investigations to find out exactly what happened. (There could be totally innocent answers, such as children dying of various diseases over the years with the markers eroding over time. Or there could be totally nefarious answers. Either way, there need to be answers.)

Others, however, are not waiting for answers, with radio host Nesta Matthews tweeting, “Burn the churches down. Arrest any former staff that were actually there & any current staff that won’t provide documentation. Sell everything they own in Canada and give it to survivors. Dismantle it completely.”

Or, as expressed by Harsha Walia, executive director of the British Columbia Civil Liberties Association (BCCLA), “Burn it all down.”

Yes, these sentiments are being expressed openly and boldly. America, be forewarned!

With the growing hostility in our country towards Christians, and with attacks on church buildings during last year’s riots, this does not seem so farfetched.

If a history professor asserted that black holes don’t exist, would anyone pay any attention to him? What about an English professor who advocates Lamarckian evolutionary theory over Darwin? How about a sociologist who believes in alchemy?

What if these folks didn’t just have weird beliefs, what if they taught these ideas in their classes? What if they wrote articles and books and gave public speeches extolling them?

The answer is obvious. They would be dismissed as kooks.

And much more. On a typical university campus, the physics department would probably demand that the history professor stop spouting fake physics or be fired. The biology department would react the same way to the espousal of fake biology.

In fact, on most campuses almost every academic discipline would try to protect its turf as well as the scientific integrity of its discipline.

With one exception: economics.

Over my long experience with the academic world, I have often marveled at the fact that people who had never had a course in economics, had never read a book on the subject, who wouldn't know what to do with a supply and a demand curve if they saw them—nonetheless feel free to speak with authority on economic topics.

If you search the economics departments of our nation's colleges and universities you would be hard pressed to find a real socialist. That's because economists know a lot about socialism. They have been studying it and thinking about it for over a hundred years.

Outside economics departments, things are different. It has often been humorously estimated that there are more Marxists on the faculty of American universities than there are in Russia or China today.

How is that possible? I blame the economists.

Economists have not only documented the failure of socialism in the Soviet Union and China, they know why the Cuban, North Korean, and Venezuelan economies are basket cases. It isn't complicated. When people at the top design a plan in which everybody who is needed to carry it out has an economic self-interest in not doing so, the plan never succeeds. Good economics is often plain common sense.

Serious scholars have also documented the human costs of concentrating economic and political power. Socialist hellholes have produced imprisonment, torture, starvation and mass murder on a scale never before imagined in human history. In the 20th century, almost 170 million people were killed by their own governments. These people were not killed in wars. They were the victims of genocidal murder.

The vast majority were murdered by socialist governments. The Russian communists were the worst (62 million) followed by the Chinese communists (35 million) and then the Nazi national socialists (20 million).

Although socialists claim that workers are exploited under capitalism, no greedy capitalist has ever begun to match what socialists have done.

Josef Stalin, Mao Tse Tung, Fidel Castro and Hugo Chávez lived like kings and accumulated vast fortunes while their own people often faced starvation. Kim Jong-un and the current rulers in Cuba and Venezuela are following in their footsteps

Chinese communist leader Mao Tse-tung was the greatest mass murderer in world history, causing at least 45 million people to be worked, starved or beaten to death. When he died, he was worth an estimated \$1 billion.

The world's second greatest mass murderer, Josef Stalin, killed 20 million, many by forced starvation. Some regard him as one of the wealthiest people of all time.

Fidel Castro's former bodyguard Juan Reinaldo Sánchez says that the communist leader "lived like a king" and "ran the country the country like a cross between medieval overlord and Louis XV." While ordinary Cubans stood in breadlines, Castro had his own private yacht and his own private island. In Havana, he lived in an immense estate with a rooftop bowling alley, a basketball court and fully equipped medical center.

The puzzle is: Why aren't these facts better known? The answer seems to be: In the classes where students should be learning them, the teachers aren't doing their jobs.

While students are getting a daily dose of socialist propaganda from economic know-nothings in the other social science departments, what have the economists been saying about the subject in their classes? Nothing. Well, almost nothing.

Pick up just about any introductory economics textbook and you will find very little about socialism. And what you do find will never be front and center. It will be stuck at the back of the book in case the instructor has time to cover it at the end of the semester.

The reason for this is understandable. Most economics teachers consider socialism to be so completely dysfunctional, they see no reason to spend any time on it.

Here is what the economics departments are missing. Given the economic nonsense that is being spewed out all over the rest of the campus, the first things students need to study in introductory economics is socialism. In fact, I believe the entire first semester should be devoted to socialism.

What starts on the campuses doesn't take long to spread. Jane Fonda, Barbra Streisand and other Hollywood celebrities don't think they need to know anything about economics in order to have strong opinions on the subject.

When is the last time you heard Streisand quote Paul Samuelson or Milton Friedman or any economist? With increasing frequency, in a very large part of the national public policy conversation, professional economists are considered completely irrelevant.

To use a military analogy, the economists have left the battlefield, leaving the students behind to fend for themselves. The nation is paying a heavy price for that less-than-honorable retreat.

One of the gravest threats to our democracy today is a powerful group of Big Tech corporations that have teamed up with government to censor the free speech of

the American people. This is not only wrong—it is unconstitutional. To restore free speech for myself and for every American, I am suing Big Tech to stop it.

Social media has become as central to free speech as town meeting halls, newspapers and television networks were in prior generations. The internet is the new public square.

In recent years, however, Big Tech platforms have become increasingly brazen and shameless in censoring and discriminating against ideas, information and people on social media—banning users, deplatforming organizations, and aggressively blocking the free flow of information on which our democracy depends.

No longer are Big Tech giants simply removing specific threats of violence. They are manipulating and controlling the political debate itself. Consider content that was censored in the past year. Big Tech companies banned users from their platforms for publishing evidence that showed the coronavirus emerged from a Chinese lab, which even the corporate media now admits may be true.

In the middle of a pandemic, Big Tech censored physicians from discussing potential treatments such as hydroxychloroquine, which studies have now shown does work to relieve symptoms of covid-19.

In the weeks before a presidential election, the platforms banned the New York Post—America’s oldest newspaper—for publishing a story critical of Joe Biden’s family, a story the Biden campaign did not even dispute.

Perhaps most egregious, in the weeks after the election, Big Tech blocked the social-media accounts of the sitting president. If they can do it to me, they can do it to you—and believe me, they are.

■ Jennifer Horton, a Michigan schoolteacher, was banned from Facebook for sharing an article questioning whether mandatory masks for young children are healthy. Later, when her brother went missing, she was unable to use Facebook to get the word out.

■ Colorado physician Kelly Victory was deplatformed by YouTube after she made a video for her church explaining how to hold services safely.

■ Kiyon Michael of Florida and her husband, Bobby, lost their 21-year-old son in a fatal collision caused by a twice-deported illegal alien. Facebook censored them after they posted on border security and immigration enforcement.

Meanwhile, Chinese propagandists and the Iranian dictator spew threats and hateful lies on these platforms with impunity.

This flagrant attack on free speech is doing terrible damage to our country. That is why in conjunction with the America First Policy Institute, I filed class-action lawsuits to force Big Tech to stop censoring the American people. The suits seek damages to deter such behavior in the future and injunctions restoring my accounts.

Our lawsuits argue that Big Tech companies are being used to impose illegal and unconstitutional government censorship. In 1996 Congress sought to pro-

mote the growth of the internet by extending liability protections to internet platforms, recognizing that they were exactly that—platforms, not publishers.

Unlike publishers, companies such as Facebook and Twitter can't be held legally liable for the content posted to their sites. Without this immunity, social media companies could not exist.

Democrats in Congress are exploiting this leverage to coerce platforms into censoring their political opponents. In recent years, we have all watched Congress haul Big Tech CEOs before their committees and demand that they censor "false" stories and "disinformation"—labels determined by an army of partisan fact-checkers loyal to the Democrat Party.

As the cases of fellow plaintiffs Ms. Horton, Dr. Victory and the Michael family demonstrate, in practice this amounts to suppression of speech that those in power do not like.

Further, Big Tech and government agencies are actively coordinating to remove content from the platforms according to the guidance of agencies such as the Centers for Disease Control and Prevention.

Big Tech and traditional media entities formed the Trusted News Initiative, which essentially takes instructions from the CDC about what information they need to "combat." The tech companies are doing the government's bidding, colluding to censor unapproved ideas.

This coercion and coordination is unconstitutional. The Supreme Court has held that Congress can't use private actors to achieve what the Constitution prohibits it from doing itself.

In effect, Big Tech has been illegally deputized as the censorship arm of the U.S. government. This should alarm you no matter your political persuasion. It is unacceptable, unlawful and un-American.

Through these lawsuits, I intend to restore free speech for all Americans—Democrats, Republicans and independents. I will never stop fighting to defend the constitutional rights and sacred liberties of the American people.

Some think tank or polling organization should ask 1,000 Americans: What is the best thing most Americans can do to make the country better?

Presumably, those most influenced by their schooling and by the media would answer something along the lines of: "fight racism" or "work to reduce in-

equality.” Whatever the specific answer, most young people—and those older who lean left—would most likely respond by citing some form of activism.

Since the early 1960s and '70s, a moral life has been defined as engaging in activism. One improves America—indeed, one becomes a good person—by fighting for a cause. That cause may be feminism, environmentalism, socialism, material equality, racial equality, LGBTQ+ liberation or the welfare state—free health care, free college tuition, free preschool, free day care, free school breakfasts and lunches, even free income.

This is a massive break with the American past. While there were always causes to champion—the abolition of slavery being the greatest and costliest—most Americans did not think the best thing they could do with their lives was to become a social activist. Indeed, the very term “social activist” is largely a creation of the second half of the 20th century.

Throughout American history until the post-World War II era, had you asked almost any American what constitutes living a good life, he or she would have offered any or all of these five responses.

- Developing one’s moral character.
- Getting married and making a good family.
- Taking care of one’s family, especially one’s parents.
- Going to church (or synagogue).
- Taking care of the poor in one’s community, usually by joining a service organization such as a church charity, a Kiwanis, Lions or Rotary Club.

My suspicion is that if one were to ask young people today, and certainly anyone on the left, you would not receive any of those five responses.

Let’s take them in order.

Developing one’s moral character

With the macro-ization of morality, the definition of moral character has changed. It is no longer working on oneself, conquering one’s demons, controlling one’s appetites—in short, fighting one’s flawed nature. When people looked to the Bible for wisdom rather than to their foolish hearts and their foolish teachers (who rely on their own foolish hearts), they knew how flawed human nature is, and therefore knew that character development meant a lifelong struggle with oneself. No longer. Character development now means struggle with a deeply flawed America, not a deeply flawed self.

Getting married and making a good family

That is the single best thing the vast majority of people can do to make a better world. Most college graduates and essentially the entire intellectual elite mock this idea. If a female college student announced on a social medium or in class that her greatest desire was to find a good man and make a family, she would be considered pathetic, brainwashed by “the patriarchy.” If, on the

other hand, she announced she would devote her life to a feminist cause or to fighting racial injustice, she would receive almost universal approbation.

Yet, what could be possibly better for society than the great majority of its people marrying and attempting to raise decent people?

Taking care of one's family, especially one's parents

This is another traditional definition of leading a good life. However, this has been subverted by three developments: first, the unprecedented number of Americans who have not made a family (i.e., a married couple with children); second, by the state taking care of more and more people—individual citizens, their children and their parents; and third, the unspoken pandemic of adult children who not only do not take care of their parents, but they have also removed them from their lives for personal or political reasons.

Going to church (or synagogue)

For the highly educated who believe that religion is irrelevant to character, I have always asked two questions: First, if religion is irrelevant to moral behavior, why are almost no violent criminals regular churchgoers? Second, if you were traveling in a strange city, it was midnight, you were lost, and you saw a group of young men walking toward you, would you or would you not be relieved to learn that they just had attended a Bible class?

Joining a service organization

Almost every American who had the time joined some group that did good in his or her community. Men joined service organizations. Women volunteered in a whole host of charities such as hospitals, schools and churches. There is less volunteering today than at any time in American history.

It's much more exciting to join a demonstration than to do any of the five things listed. And it comes with the added bonus of thinking well of oneself—without having had to do any of the tough work on one's own character.

That, in a nutshell, is the genesis of our present existential crisis. People don't understand that the best thing they can do for this society is to lead an individually good life and raise honorable children, not join a protest movement.
