Looking back to April 2024, an article by Melissa Quinn titled "Justice Neil Gorsuch Is Not Pleased With Judges Setting Nationwide Policy; but How Common Is It?" was posted at cbsnews.com on April 10, 2024. Following are excerpts of the article.

When the Supreme Court heard arguments in two high-stakes, separate cases last month, Justice Neil Gorsuch raised concerns about how both disputes arrived at the court.

The cases – one involving the Biden administration's communications with social media companies and the other (the accessibility of a commonly used abortion pill) landed before the justices after federal district courts issued nationwide orders that blocked federal agencies from taking certain actions.

"Rash" of universal injunctions

Known as nationwide or universal injunctions, there far-reaching orders bar the government from enforcing the policy at issue against anyone, anywhere in the country, and extend beyond the relief necessary to protect the plaintiffs who brought the lawsuits. And they appeared to trouble Gorsuch, who lamented there has been a "rash" of them lately.

Michael Morley (a law professor at Florida State University) said: "Rather

than having what you might think of as a functional judicial process where if you do have important, unsettled controversial issues, the courts can give it appropriate time and consideration, you have everybody's right throughout the nation being flipped on and off like a light switch."

A study published Wednesday in the Harvard Law Review looked at the number of those injunctions issued since 1963, and found they spiked in the four years former President Donald Trump was in office.

Following is information from a data-set from the Justice Department.

 Researchers identified at least 127 nationwide injunctions issued from 1963 through 2023.

• Of those, 96 have been entered since 2001 – More than half, 64, blocked the Trump administration from enforcing or implementing its policies.

How does that number compare with other presidents?

- George W. Bush's two terms 6 nationwide injunctions.
- Barack Obama's two terms 12 nationwide injunctions.
- Joe Biden's one term 14 nationwide injunctions

[Remember – Trump's number was 64.]

"Extreme forum shopping"

Morley said a single judge's power to enter a nationwide injunction incentivizes "extreme forum shopping," in which plaintiffs strategically bring their case in a specific court before a judge who will be most favorable to their arguments.

Morley said: "There are outlier judges on all sides. You can go to that outlier judge and are systematically having the most controversial, cutting edge, hot-button constitutional issues being settled and resolved by the ideological outliers rather than a more representative cross section of the judiciary."

Courts have over the past few years become the arena for hashing out highprofile political disputes, as congressional gridlock puts pressure on the president to take executive action to implement his policy agenda, said Nicholas Bagley (a law professor at the University of Michigan). When presidents try to act unilaterally in "unusual or aggressive ways," Bagley continued, "there's a ripe opportunity for a lawsuit, and if you're bringing one of these lawsuits, you're going to do your [hardest] to bring it in front of a friendly forum."

A judge who is more receptive to the challenger's arguments, he said, may come to see a nationwide remedy as the more appropriate means of reining in a president.

Bagley said: "It's a combination of a bunch of factors coming together."

- There are almost 700 federal district court judges.
- I say "almost," because while officially there are 677 of them, some retired judges have

taken senior status and may sit from time to time on cases – so the figure is inexact on any given day.

• Since President Trump was sworn in for a second term, there has been an avalanche of

cases seeking relief from executive actions – last month alone, district court judges issued 15 temporary restraining orders.

• That's more nationwide injunctions than there were issued for the first three YEARS of

the Biden Administration. District court judges are out of control."

A Temporary Restraining Order (TRO) is designed to maintain the status quo after a claim is made that there is an emergency requiring the court to maintain the matter in a holding pattern – usually for 10-14 days – until a hearing on the issue can be held.

A TRO can be granted ex parte – that is with only the plaintiff being present

and without a hearing on the issue at all.

The plaintiff must show the likelihood of success on the merits of the claim and that the harm to him outweighs any potential harm to the opposing party.

To get one, the plaintiff has to show the likelihood of irreparable injury if the court fails to act.

After a hearing, the court may issue a Preliminary Injunction (PI) directing some action or continuing the initial restraint until a full trial on the matter is held.

To obtain a PI that lasts throughout the course of litigation, the plaintiff must meet a higher standard of proof.

A TRO requires the applicant to show a substantial likelihood of success and immediate harm, while a preliminary injunction involves a more rigorous evaluation of the merits, balance of equities and public interest.

There are 94 district courts and 12 federal courts of appeals, which hear and decide appeals from district courts.

Generally, TROs are not appealable, but preliminary injunctions are.

Some of the TROs issued against the administration read more like preliminary injunctions, and no matter how they are titled, if they do more than maintain the status quo for a short period, the appellate courts should step in and assert jurisdiction.

According to Bill Shipley, most of these injunctions will not survive appeal: "I think SCOTUS is going to end up staying several of these, take up a small number, and then issue a small number of decisions that will force District Judges to reconsider and rethink their rulings. But they are unlikely to take a lot of these cases up individually to decide them on the merits. They will rely on district judges to change their decisions, and the Appeals Courts to smack down those who don't."

It's clear that the curtain must fall on the notion that hundreds of unelected district court judges (of often outlying political beliefs and of various levels of judicial temperament and legal ability) should be permitted to act as Chief Executive.

Attorney Alan Dershowitz said Tuesday that President Donald Trump and Congress had multiple options to rein in the judge who tried to block the deportation of over 200 members of the Tren De Aragua prison gang.

• Dershowitz said: "I think Congress can do more to facilitate the exit of these bad guys,

and they should do more, and they can do more to curtail the jurisdiction of courts. They can pass a statute saying a district court has jurisdiction only to grant an injunction that covers his district, to his circuit."

Dershowitz also dismissed the notion that the Trump administration's action precipitated a constitutional crisis. (Trump and Congress could rein in the lower court judges.)

• Dershowitz said: "Congress clearly has the authority. It can abolish the district courts all

over the country. It could say we don't have any more district courts. Nothing in the Constitution about district courts. It just says that you know it can have, there can be lower courts, but it doesn't indicate how many there have to be and where the circuits are and how many court of appeals judges [or] district court judges. Those are all issues for Congress, and Congress can have greater input than they now do. So, there is no constitutional crisis, let's be clear, but Congress can help avoid the constitutional clashes by legislating on some of these issues."
